Appoint Additional Seasonal Hours Highway
Laborer – Duthoy

WHEREAS, the Highway Department has experienced a recent resignation of Megan Faulkner; and

WHEREAS, the resignation has created a gap in staffing and placed additional demands on current personnel during the peak seasonal workload; and

WHEREAS, it is necessary to maintain adequate staffing levels to ensure the continued efficiency and safety of operations;

NOW, THEREFORE, BE IT RESOLVED:

Sec. 1. That the Town Board of the Town of Sweden does hereby appoint seasonal laborer John P. Duthoy to additional seasonal duties in the highway department as needed.

Sec. 2. That the appointment does not constitute an offer of permanent employment or any benefits that are normally attached to permanent appointments.

Sec. 3. That the rate of pay for hours worked on highway duties will be \$18.00 per hour for a maximum of 240 additional highway hours of highway work hours in 2025.

Sec. 4. That the expenditure for these additional hours shall be charged to the appropriate departmental labor budget line and monitored accordingly.

Amend Agreement with New York State
for Control of Snow and Ice
