

LEGAL NOTICE

NOTICE IS HEREBY GIVEN that, pursuant to the New York State Governor's Executive Order Nos. 202 through 202.15, and other advisories issued by Federal, State and Local Officials related to the Covid-19 virus, Sweden Planning Board Meetings will not be held in person until the COVID-19 State of Emergency has concluded. In accordance with the Governor's Executive Order, the June 8, 2020, 7 p.m., regularly scheduled Planning Board meeting will be held via virtual ZOOM videoconferencing, and a transcript will be provided later. The public will have an opportunity to see and hear the meeting live.

Public hearings according to the provisions of Town Law, and the Town of Sweden Land Use Development and Subdivision Regulations, will be held by the Planning Board on Monday, June 8, 2020, commencing at 7 p.m. to consider the following applications.

Application of David Versteeg, 1800 W. Sweden Road, Brockport, New York, for approval of the Versteeg Subdivision and Site Plan, located at 1800 W. Sweden Road, Brockport, New York. Applicant is proposing to combine two existing lots and construct a single-family home to be serviced by a private well and septic system. Site includes an existing barn and shed. The properties are owned by David Versteeg, tax account numbers: 128.01-1-1.12 and 128.01-1-1.112.

Also, application of Laura and Darrell Bentley, 5605 Brockport-Spencerport Road, Brockport, New York, for amended site plan approval. Applicant is proposing to construct a 50 ft. by 50 ft. barn located to the west of the existing building. The barn will have an enclosed walkway to the existing building. The property is owned by Joseph and Anna Rossi, 33 Colby Street, Spencerport, New York, tax account number: 084.02-1-38.
