A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, January 23, 2018 after the closing of two public hearings.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Robert Muesebeck, Councilperson Mary Rich and Councilperson Lori Skoog. Also present were Finance Director Leisa Strabel, Town Architect David Strabel, Superintendent of Highways Brian Ingraham, Town Attorney Jim Bell and Town Clerk Karen Sweeting.

Visitors present were Joan Hamlin, Christine Hamlin, Susan Smith, Laurence Vaughan, Pat Leonard, Ken and Dorothy Reid, John Zima, Wayne Zyra, Charles and Dottie Scott, Charles Sanford, Deputy Village Mayor Bill Andrews and Village Trustee Annie Crane. Mike Bove from Monroe Ambulance arrived at 7:36 p.m.

Supervisor Johnson called the meeting to order at 7:24 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence.

Supervisor Johnson asked if there were any comments from the visitors.

Resident Charles Scott asked when the board would discuss the water survey and when Jay Grasso would be presenting his report. Supervisor Johnson said he will report on this later in the meeting.

Deputy Village Mayor Bill Andrews announced that Gary Skoog was selected as the winner of the Monika Andrews Creative Volunteer Leadership Award. (Runners Up - Hanny Heyen and John Rombaut) Awards will be presented at the February 5, 2018 Village Board meeting.

APPROVAL OF MINUTES

Councilperson Muesebeck made a motion that was seconded by Councilperson Hayles to accept the minutes of the Organizational Meeting held on January 2, 2018. All voted in favor of the motion. Motion adopted.

SUPERVISOR'S CORRESPONDENCE

No correspondence noted

REPORTS

Councilperson Hayles reported that she met with Recreation Supervisor Jill Wisnowski and her "team" at the SCCC. They discussed programming and will meet on a regular basis to develop the best programs for our community.

Councilperson Muesebeck provided lunch for the Highway Department as a thank you for all their hard work keeping the roads clear and safe for all. He also met with Buildings and Grounds and reported that the Lodge at the Town Park should be completed within the next few weeks.

Councilperson Skoog reported that she is now the liaison for Dog Control and Sweden Town Court. She has talked with both departments. Kathy Beaumont is requesting a couple of items for Dog Control. Mrs. Skoog mentioned that her reports on the court will be minimal because they receive the majority of their equipment through the state court administration. (The court is an independent branch of the town.) Mrs. Skoog will be attending the Sweden Senior Association's Souper Bowl event January 27, 2018.

Supervisor Johnson added that the court received a donation in memory of Judge William Cody that will be used to purchase either a desk-top scanner or a sound system for the courtroom. The court will be applying for a JCAP grant for equipment not purchased using the donation.

Councilperson Rich reported that she remains the liaison for the Seymour Library and will also be attending the Souper Bowl event. Mrs. Rich will be attending Governor Cuomo's Council on Women and Girls Regional Empowerment Forum with Lt. Governor Kathy Hochul at MCC.

Supervisor Johnson also plans to attend the Souper Bowl event.

Mr. Johnson reported that he received a lot of feedback relative to the closure of town facilities on January 5, 2018 and the storm on January 12, 2018. He explained the reason for the closure on the 5th primarily out of concern for employees traveling to work, wind chill and drifting snow. Mr. Johnson was able to contact the majority of employees, but also found that the town did not have any procedures in place for such situations. He drafted an emergency closing procedure manual that he presented to department heads and the board for review. (See Resolution No. 27 of this meeting) Mr. Johnson added that he did not close town facilities on January 12th because he was assured that roads would be open for travel.

Supervisor Johnson announced that there will be quarterly department head meetings and has drafted new rules and procedures for Town Board meetings. (See Resolution No. 26 of this meeting) He met with Town Architect, David Strabel, to discuss new restrooms at the Town Park and an adult activities addition at the SCCC. Mr. Johnson sent letters to a variety of companies asking them to consider relocating to the Town of Sweden in an effort to bring more goods and services to our community.

Supervisor Johnson met with Jay Grasso. Mr. Grasso indicated that he would be ready to present his survey findings and final report by the end of January. They discussed funding sources. Mr. Johnson would like the board to pursue water for the remaining areas of the town. The next step is an engineering study that would include all areas not studied in the most recent water study. Mr. Johnson met with the Town Engineer to request a proposal for the remaining study. He would like to see this done before May 2018.

Resident Dottie Scott mentioned that several residents have been involved with the water committee for several months now and asked to be involved in the remainder of this process. Supervisor Johnson indicated that public support and involvement will be necessary for this project to move forward. Resident Pat Leonard said this has been a slow process and was pleased to see the new board showing an interest in pursuing water for the remainder of the town.

Supervisor Johnson reported that the location of the proposed "splash park" at the Town Park has been determined. He spoke with Walt Windus (Stormwater Manager for the Town of Sweden) about the drainage of water from the splash park into the pond. Stormwater regulations allow this type of drainage and it is a good way to recycle the water at a lower cost.

Supervisor Johnson met with Robert Cantwell (BME Associates) and Rick Kartes (Stonehaven Commercial, LLC) to discuss the sewer apportionment for the Stonebriar project on Fourth Section Road. Mr. Johnson received several calls and emails regarding the powerline easements near Talamora Trail. The utility company is clearing trees and brush along the powerline and will be replacing poles. Superintendent of Highways Brian Ingraham has walked the length of the easement with the tree removal company to help mitigate issues with the residential properties along the easement.

Supervisor Johnson attended the Association of Towns training for newly elected officials. (Councilperson Hayles also attended this training.) He met with Fire Marshal Michael

Vergari. Mr. Vergari would like to attend an upcoming work session to go over required NIMS training and the POD (Point of Dispensing) program. They also discussed the need for new radio equipment that would enable the Fire Marshal to communicate with agencies using all frequencies. Mr. Johnson suggested meeting with the Brockport Fire Commissioners to discuss this.

Supervisor Johnson now has a Town of Sweden Supervisor Facebook page.

Superintendent of Highways Brian Ingraham reported they are very busy with snow and ice operations and will begin vegetation maintenance within the right-of-ways on Gallup Road, Campbell Road and East Canal Road.

Town Attorney Jim Bell reported updates to assessment litigation with WalMart and requested the engagement of professional appraisal services with Midland Appraisal Associates, Inc.

Mike Bove from Monroe Ambulance informed the board that they have added extra staff to cover calls in the Village of Brockport and things are going well.
