DEGOLUTIONG

Superintendent of Highways Brian Ingraham reported that they are trimming brush overgrowth on Town roads, focusing on snow and ice control, and have teamed with the Village to clear brush and debris from Coleman Creek stretching from Route 19 to Canal Road. Mr. Ingraham is also drafting the 2017 summer road work program.

Finance Director Leisa Strabel discussed with the board Governor Cuomo's recent strategy to control local government spending. She indicated that the requirements of such plan may affect state aid to local municipalities. Mrs. Strabel explained the recent Family Care Act and told the Board that the Town is exempt. The Board also discussed the possibility of passing on the CDBG grant application this year as no project has been determined.

Councilperson Rich attended the Village Tax Relief Task Force Committee meeting and the Seymour Library Board meeting.

Councilperson Skoog reported on the Water Committee meeting. Pat Leonard shared survey statistics with the committee. The Town Board will meet with Jay Grasso at an upcoming work shop to present the survey findings. Mrs. Skoog would like to have a public meeting in April with several outside agencies to answer questions and obtain information. She encouraged residents to bring a list of questions to the February 16th meeting. The committee will draft a list of questions for the agencies so they can come prepared with answers.

Councilperson Muesebeck reported that two Solar Committee meetings have been held and they have been obtaining information from other towns and are drafting a proposed local law for consideration that will involve requirements for commercial farms – the current code has requirements in place for residential.

Supervisor Carges reported that he met with the Village Mayor to discuss joint projects.

 February 7, 2017 at 7:00 PM at which hearing all interested persons shall be heard concerning the enactment of Local Law #2-2017 adding proposed Article VII Solar, Wind Energy and Farm Waste Energy Systems to Chapter 164 Taxation.
- Sec. 2. That the proposed Local Law reads as follows:

Solar, Wind Energy and Farm Waste Energy Systems

This Article is adopted pursuant to the Authority of Real Property Tax Law § 487 which allows for the adoption of a Local Law providing that the provisions of § 487 of the Real Property Tax Law allowing for exemptions from taxation to the extent of any increase in assessed value due to the construction of such systems shall not apply to any such systems constructed within the Town of Sweden after the effective date of this Article.

- Sec. 3. That the Town Clerk is hereby authorized and directed to cause a notice of the public hearing to be published in the official newspaper of the town as required by Town Law.
- <u>Sec. 4.</u> The text of the proposed Local Law is available in the office of the Town Clerk during regular business hours and on the Town website.
