A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, February 27, 2018.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Mary Rich and Councilperson Lori Skoog. Councilperson Robert Muesebeck was absent. Also present were Finance Director Leisa Strabel, Town Attorney Jim Bell, Superintendent of Highways Brian Ingraham and Town Clerk Karen Sweeting.

Visitors present were Joan Hamlin, Christine Hamlin, Susan Smith, Don Grentzinger, Justin Rabjohn, Barb Deming, Wayne Zyra and Deputy Village Mayor Bill Andrews.

Supervisor Johnson called the meeting to order at 7:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence.

### PRIVILEGE OF THE FLOOR:

Donald Grentzinger, a member of the Sweden Farmers Museum Committee, informed the board that the committee is in the preliminary stages of planning a Harvest Festival in September 2018. He asked if the committee needed approval for the event that would take place on a Saturday from 9am to 4 pm. Supervisor Johnson asked that the committee put together a plan and present it at an upcoming work session.

### REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported they have been busy with equipment maintenance and tree trimming along Owens Road, East Canal Road and West Canal Road in an attempt to keep drainage ditches clear. Supervisor Johnson noted that East Canal Road has not flooded as often as in the past. Mr. Ingraham stated that the Canal Corporation put in measures to control drainage in that area and it seems to be working well.

Town Attorney Jim Bell reported that the Solar Committee met to discuss several concerns expressed by the Building Department. The committee will meet again to draft suggested modifications to the current law. Supervisor Johnson mentioned that he attended a session on solar energy at the Association of Towns conference. Mr. Bell requested that any potential applicants with questions on the current law be directed to contact his office. Supervisor Johnson said that a potential applicant has indicated they will be going to the Zoning Board of Appeals and he is aware of a second potential application.

Jim Bell also reported the ongoing assessment litigation with WalMart. Supervisor Johnson mentioned also learning at the Association of Towns conference of legislation proposing to outlaw the use of "dark stores" in valuating commercial property. Discussion.

Finance Director Leisa Strabel reported that the auditors have finished on-site last week and the AUD is almost complete.

Councilperson Hayles reported that the Spring recreation brochures will be out in homes by March 10<sup>th</sup>, the Del Lago trip was a success and more trips for seniors are being planned for the Spring. The Easter event is scheduled for March 24<sup>th</sup> and proceeds from the breakfast will go to the food shelf. Mrs. Hayles reported that Recreation Supervisor Jill Wisnowski met with representatives from Bison's Baseball to discuss the upcoming season. The Bison's raised the issue of concessions at the Town Park. (The board will discuss this at an upcoming work session.) Mrs. Hayles also reported that there are 19 reservations for the Lodge at the Town Park.

Councilperson Rich attended a Seymour Library Board meeting. The library will be conducting interviews of candidates for Chris Daily's position. She is retiring after 28 years of service. Her retirement party is scheduled for March 29, 2018.

Councilperson Hayles asked how the library's finances are and if the board had someone with a strong business background to advise them. Mrs. Rich indicated that the library board goes over the budget thoroughly. She added that the library was able to extend some hours due to the sizable donation from Clarkson Supervisor Underwood. Mrs. Hayles said it was too bad they weren't able to increase Director Carl Gouveia's salary. She understood he willingly took a cut in salary and feels that Mr. Gouveia is a well-qualified director.

Supervisor Johnson added that when he met with the Village Mayor, Clarkson Supervisor and Mr. Gouveia, he indicated that the Town would be receptive to requests for additional funding. He asked that Mr. Gouveia put together a "dream" budget to present to the boards. Mr. Johnson said he would like to see what it would cost to fully fund the library, then the boards can take a look at what they can do.

Councilperson Skoog asked about the library's desire for a district. Mr. Johnson would like to see if the towns and village can work together. Mrs. Skoog asked how any additional funding would be based – on population or equally by three. Supervisor Johnson answered per capita would be logical and felt it was worth coming up with a solution.

Councilperson Skoog said she received three calls from residents that saw the article pertaining to extending water in the Town. She asked when the committee would be meeting again. Supervisor Johnson felt that they should wait until the additional water study was received from the Town Engineer. Jay Grasso has finalized the survey and submitted the required letter. They are waiting for the response. Mr. Johnson anticipated meeting with the committee in May then proceed with public information events.

Supervisor Johnson reported for Councilperson Muesebeck that the tables were in for the Lodge at the Town Park, but still waiting for the chairs. He hopes they will be in before the first rental. Mr. Johnson had an opportunity to talk with playground/splash park vendors at the Association of Towns conference. He brought back catalogs that he will share with Wayne Zyra of the Sweden Community Foundation. He would like to get input from the foundation and proposed a meeting with them.

Mr. Johnson reported an incident that closed a portion of Redman Road. It was a domestic dispute that involved an altercation with a passerby. Mr. Johnson spoke with the Monroe County Sheriff C-Zone Commander and announced that the situation was under control.

Mr. Johnson reported that he attended the Association of Town conference and was able to attend sessions on the following topics: social media, project review, cloud computing, ethics, solar energy codes, vacant property, funding for water, budgeting, accounting for capital assets. He felt it was a great conference and suggested increasing the board's budget to allow other members of the board to attend.

Mr. Johnson would like to tentatively schedule a grand opening event for the Lodge at the Town Park – proposing April 14, 2018. He is obtaining quotes for a new AV system in the courtroom that may include a television screen for presentations. Councilperson Skoog indicated she may have a donor for the television screen. Mr. Johnson spoke with Greece Supervisor Bill Reilich about the splash park in Greece. Mr. Johnson suggested taking a tour of their park.

Mr. Johnson shared several concerns for the safety of pedestrians on Owens Road and will be meeting with Superintendent of Highways Brian Ingraham to discuss the process of requesting a lower speed limit. He also obtained information regarding a possible grant for

sidewalks along Owens Road. Mr. Johnson placed an ad in the Suburban News requesting letters of support from residents along Owens Road. The letters will be included in the grant application. Mr. Johnson would like to move forward quickly on this.

Mr. Johnson also reported that the cleaning and deposit requirements for the Lodge at the Town Park are in place; sales tax revenue has increased from last year; and the construction of the small playground near the Lodge at the Town Park will begin (received funding from a grant in 2015 in the amount of \$25,000). Mr. Johnson would also like to move forward on the path to the canal at the Town Park.

Supervisor Johnson provided Councilperson Rich with an old sample of an employee review report.
