A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, April 10, 2018.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Robert Muesebeck, Councilperson Patricia Hayles, Councilperson Mary Rich and Councilperson Lori Skoog. Also present were Finance Director Leisa Strabel, Town Attorney Jim Bell and Town Clerk Karen Sweeting. Superintendent of Highways Brian Ingraham was excused.

Visitors present were Joan Hamlin, Christine Hamlin, Susan Smith, Wayne Zyra, Kevin M. Johnson, Adam Rich, Julie and Frank Lapinski, and Michael Bove from Monroe Ambulance.

Supervisor Johnson called the meeting to order at 7:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence for those in the military and for the loss of 7 year old Abraham Cardenas.

PRIVILEGE OF THE FLOOR:

Resident Frank Lapinski commented on the resolution pertaining to changing the hour of the work sessions and meetings. He felt there was no merit to the idea of changing the hours except to meet the schedule of one board member. He added that the Deputy Supervisor could step in and run the meetings. Mr. Lapinski was disappointed that more residents did not attend this meeting to express their concerns with the 5:00 pm time change.

Michael Bove from Monroe Ambulance informed the board that Monroe Ambulance has been conducting wellness education and blood pressure clinics for the past $1\frac{1}{2}$ years at locations in the Town of Sweden - SCCC, Royal Gardens, Lodge on the Canal, Park Avenue Apartments. They see approximately 40-60 individuals each week. The program has reduced the number of unnecessary hospital visits and has saved thousands of dollars in hospital costs. They were approached to partner with the Rochester Regional Geriatric Group. They plan to publish a paper nationally detailing the success of the program and the study conducted. Mr. Bove added that the Town of Sweden has contributed to their success by allowing access to residents.

CORRESPONDENCE:

 Superintendent of Highways, Brian Ingraham – recommendation – appoint HEO Kenneth Bell (see Resolution No. 58)

REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Councilperson Hayles commented that she was very proud of Recreation Supervisor Jill Wisnowski and how she handled the recent loss of 7 year old Abraham Cardenas. She was very professional and has encouraged her staff to take time and seek counseling in dealing with this tragedy. Mrs. Hayles announced several Spring programs as well as several SSAI sponsored programs, including the garage sale and Mother's Day lunch. The Give-a-Lift program is up and running and she has seen it advertised in area church bulletins. Mrs. Hayles reported that letters have been sent to the Bison Baseball parents letting them know that concessions will be up and running for the baseball season. The counter system is in and Mrs. Hayles is looking forward to seeing the data. Councilperson Rich asked if any concessions were made available for the basketball tournament that was held at the SCCC. Mrs. Hayles will check on this.

Councilperson Muesebeck reported that the restroom construction at the Town Park is moving along – finishing block work and roof trusses, weather permitting. He also mentioned that Jeanne Arieno re-certified with Monroe County Health Department and is getting ready to

open the concession stand at the Town Park. Mr. Muesebeck requested the purchase of a storage rack for the round tables at the Lodge for \$150.

Councilperson Muesebeck indicated that Superintendent of Highways Brian Ingraham was excused from the meeting. Mr. Muesebeck shared Mr. Ingraham's report with the board. They are working on snow equipment restoration, removing snow fence and downed trees. The Highway Department, along with 17 student volunteers, cleaned up downed tree limbs and brush at Lakeview Cemetery filling 7 dump trucks.

Councilperson Skoog spoke with Court Clerk Tracy Caporale and stated no needs or concerns for the court. Mrs. Skoog would like to attend a court session and shared the court calendar with the public present. She mentioned the upgrades to the courtroom that Supervisor Johnson is looking into and thought they would be helpful to the court as well as the Town Board. Mrs. Skoog also spoke with Dog Control Officer Kathy Beaumont and reported that as part of a new regulation, the dog control truck needs a crate bolted in the back of the truck for transporting dogs. The free rabies clinic is scheduled for Saturday, May 5th from 9am to noon and all are welcome to take advantage of the clinic – no resident requirements. Mrs. Skoog informed the board that she was contacted by someone from the Bison's baseball team and they would like to meet with the Town Board. She forwarded some concerns to the Town Board and to Buildings and Grounds. Mrs. Skoog attended a SSAI meeting at the SCCC and mentioned that the quilters gave the surviving Cardenas child a quilt and will be giving one to the grandmother as well.

Councilperson Rich reported that she attended a Sweden Democratic Committee where Sweden Community Foundation representatives Jack Milner and Mike Myers spoke about the goals and objectives of the foundation. Mrs. Rich appreciated the information shared and added that she would like to discuss the field fees charged to the Challenger Baseball group at an upcoming work session. Mrs. Rich attended the retirement event for long-time library employee Christine Daily – celebrated 28 years of service. Mrs. Rich presented the rough draft of the performance appraisal to the other board members to review.

Mrs. Rich received a letter from ProBrockport indicating that the proposed community forum is on hold for now. She contacted the Association of Towns and informed Supervisor Johnson that it would not have been illegal for the Town Board to participate. Supervisor Johnson clarified that it was not a question of if it was illegal, he just felt it was not appropriate for the Town Board to participate. Mrs. Rich also asked the Association of Towns and the Committee on Open Government to clarify conflicts of interest, particularly who reviews and makes decisions pertaining to conflicts of officials for the Town. The Committee on Open Government offered the opinion that it is the entire board's decision to review conflicts of interest.

Supervisor Johnson was contacted by residents on the south side of Fourth Section Road asking if sewer could now be brought to the area. Mr. Johnson stated that it was studied several years ago and at that time, not affordable due to multiple bores under the road. Stonebriar development (recently approved sewer district extension) requires one bore under Fourth Section Road. Mr. Johnson feels this is a good time to revisit the possibility of a south side sewer district. He would like to get the Town Engineer to provide an estimate of the cost. Councilperson Skoog asked if the annual fee for the current district would be lower for the residents if the south side formed. Supervisor Johnson indicated that the south side would be a separate district with their own debt service. Discussion. Councilperson Skoog asked if a letter could be sent to the residents that would be included in the proposed district to see if there was interest. Supervisor Johnson said that it would be helpful to the resident to know and understand the costs involved. The board agreed to move forward with obtaining cost estimates for a south side district.

Supervisor Johnson met with Lucas Vandervort, who was representing COVA (Central Orleans Volunteer Ambulance) and Brockport Ambulance, to discuss Brockport Ambulance's plan to partner with COVA and resume service to the Village of Brockport. Mr. Johnson also met with an AV contractor to go over the upgrades to the system in the courtroom. Councilperson Skoog will look into obtaining a TV screen.

Supervisor Johnson indicated that he has had conversations with the Bison's Baseball group and their concerns. They recognize that some of their items are not practical. Many are basic maintenance items that Supervisor Johnson has already discussed with Buildings and Grounds to address this year.

Supervisor Johnson announced the Village of Brockport Open House at their new location on Wednesday, April 11th from 2 pm to 5 pm, the calling hours for 7 year old Abraham Cardenas also on Wednesday, April 11th from 4 pm to 6 pm and encouraged everyone to attend the Lodge Grand Opening on Saturday, April 14th from 10 am to 2 pm.

Town Clerk Karen Sweeting reported another successful Judge William Cody Memorial Blood Drive.

Finance Director Leisa Strabel announced that an active shooter training session has been scheduled for staff to attend on May 10, 2018 at 8 am.

Town Attorney Jim Bell reported that the Solar Committee will be meeting on Sunday with Planning Board Chairman Craig McAllister and Building/Code Enforcement Steve Lauth to go over the proposed changes to the solar law.
