Councilperson Rich reported that the Village Tax Relief Task Force committee presented their reports to the Village Board and felt the report was well thought out. Discussion. Mrs. Rich also attended the Seymour Library's After Hours Event "kick-off" meeting.

Councilperson Skoog detailed the upcoming free Albany Symphony concert to be held July 7th at the Welcome Center.

Councilperson Muesebeck reported that the solar committee met to discuss changes to the draft local law.

Supervisor Carges reported that he is gathering letters of support for the Canalway Grant application. He was unable to attend the most recent meeting with the County Executive to discuss shared services, but should be able to attend the next one on July 12th. Mr. Carges reported that a draft lease agreement was received from Lifetime Assistance and would like the Town Attorney to review it.

Mrs. Wisnowski informed the board that she is excited about combining the services offered at "The Lodge" with the SCCC and the staff is comfortable and ready to move forward with the transition plan.
