Fifty-seven children with disabilities participated and each received a certificate. It is a well-run program and the kids all had a great time. He commended several of the organizers of the event, naming Jack Milner, Mike Myers, Wayne Zyra and Bob Jones. Mr. Muesebeck held another solar committee meeting to make suggested changes to the solar law. They considered several comments from the first public hearing and feel they are close to a final draft.
