Others were present but did not sign in.

Supervisor Carges called the meeting to order at 7:00 p.m. and asked everyone present to say the Pledge to the Flag.

Mr. Carges asked if there were any comments from the visitors.

Brockport Ambulance Chief Cody Dean reported continued improvements and the recent showing of public support with placement of signs in the Village and Town. Mr. Dean requested that the Board consider not renewing the contract with their current provider, but consider contracting with Brockport Ambulance.

Seymour Library Board member Sri Ram Bakshi stated that at past meetings the pros and cons of forming a library district have been explained. Currently the Governor has legislation under consideration to move forward with forming a library district. Mr. Bakshi feels that the Towns' support is crucial. He would like the residents to have the ability to decide and vote on the formation of a district.

Resident Peter Hare felt the Town Board has done an outstanding job in contracting with Monroe Ambulance. He commented on the signs supporting the Brockport Ambulance located in the Village and felt that Village residents were telling the Town what they should do. Mr. Hare would like the Town Board to leave the contract as is unless there are problems with the service.

Seymour Library Director Carl Gouveia stated that he has been to several meetings to discuss the proposed district formation. He then apologized for any miscommunications and/or assumptions that have recently taken place surrounding the legislation in front of the Governor. Mr. Gouveia detailed the steps the library has taken to get to this point.

Resident Dean Westcott asked that the Board consider contracting with Brockport Ambulance. He credited the Brockport Ambulance for saving his life.

No other comments.

*Supervisor Carges read the following prepared statement:

"Sadly I am disappointed that I have to vote in the affirmative for this resolution. For the last two years this Board saw the need to support the Seymour Library with additional monies that were requested by them. Unlike both the Village Board and the Town of Clarkson Board who did not support the Seymour Library Board's budget requested increases for 2014 & 2015. Giving the library board their requested monies was no easy task for my Board, considering the past history of the way the Seymour Library's budget requests were decided upon by the three municipalities. This Board stuck its neck out and gave the library what they asked for. If a library district is formed Sweden Taxpayers will have an additional tax on their January tax bills. As it stands now, Sweden Taxpayers outside the Village of Brockport pay no additional fee for their share of the budget for the library as this cost is covered by sales tax revenue. As Town Supervisor I cannot support creating another taxing authority in our Town."

Monroe Ambulance representative Mike Bove addressed the Board. He presented a yearend report to the Board. He explained that with the current provisions of healthcare, the ambulance must run as a business with a plan to satisfy the needs of today as well as plan for the future. All costs of business are increasing. Mr. Bove shared examples of equipment costs and the limited life span of equipment with replacement costs. He shared that several providers with Monroe Ambulance reside within the Town and several frequent businesses here – many on staff have a vested interest in this community.

Mr. Bove provided statistics of service, calls and response times. He explained the current standards that are in place for providers and how Monroe has met those standards. Mr. Bove discussed several examples, backed up by 911 Center data, of Brockport's coverage. He felt the need to clarify some issues due to the recent articles and social media.

Mr. Bove explained that because of ObamaCare more people have health insurance but also have to pay more out-of-pocket for high deductible plans. Currently there is proposed legislation in the assembly and senate that will allow paramedics to perform non-emergent care without taking the patient to the hospital. Monroe Ambulance is implementing that process and currently have two providers in the program. Mr. Bove anticipates to have this in place by fall.

Mr. Bove thanked the Board for their time and stated that he understood the difficult decisions that Town Boards' have to make.

All of the Board members reviewed the invoice audit journal. Councilperson Muesebeck made a motion that was seconded by Councilperson Roberts authorizing payment of the bills in Abstract 7 dated July 28, 2015 in the amount of \$310,956.59.
