Councilperson Donald Roberts reported that he met with a representative from Genesee Valley Foundations to go over the repairs to several foundations and stones at the High Street Cemetery. Mr. Roberts mentioned that some of the stones are beyond repair and will be set in concrete for preservation. There are funds available in the cemetery trust fund. These repairs will take place in stages. Mr. Roberts also mentioned that Roger Evans of the Buildings and Grounds Department made the new High Street Cemetery sign.

Supervisor Robert Carges reported that he met, along with Councilperson Muesebeck, with Rochester Cornerstone Group to discuss a project on Owens Road. Mr. Carges and Clarkson Supervisor Kimball attended a Seymour Library Board meeting to discuss the recent veto by the NYS Governor to the proposed legislation relative to forming a library district. The three municipalities – Clarkson, Sweden and Brockport – met to discuss options to the current budget formula for the library budget. Mr. Carges met with Superintendent of Highways Brian Ingraham and Foreman Adam Shade to go over the condition of .9 miles of Whittier Road. He also met with Brian Ingraham and Todd Dobson and Roger Evans from the Buildings and Grounds Department to discuss the preliminary plans from MRB Group for the Dog Park at the Sweden Town Park. Mr. Carges announced that Kathy Beaumont, Dog Control Officer for the Town of Sweden, recently resigned her position as the Dog Control Officer for the Town of Clarkson. This does not affect her position at the Town of Sweden. Mr. Carges thanked Finance Director Leisa Strabel for her hard work on the 2016 proposed budget.
