The purpose of the special meeting was to vote on the TABLED resolution pertaining to the fireworks application received from Pork for Patriots c/o Paul & Kelly McCracken, 701 White Road, Brockport, New York for September 24, 2016.

RESOLUTIONS

RESOLUTION NO. 84 Approving Fireworks Application and Permit –  
Pork for Patriots c/o Paul & Kelly McCracken  
– White Road - September 24, 2016

WHEREAS, an application for the display of fireworks has been received from Young Explosives on behalf of Pork for Patriots c/o Paul & Kelly McCracken, 701 White Road, Brockport, New York for consideration by the Town Board. Said display to be held on September 24, 2016 at 9:15 PM at McCracken Farms, 701 White Road, Brockport, New York; and

WHEREAS, the Fire Marshal for the Town of Sweden has approved said application.

NOW, THEREFORE BE IT RESOLVED:

- Sec. 1. That the Town Board hereby approves the application for the display of fireworks at the McCracken Farm on September 24, 2016 and authorizes the Town Clerk to issue a permit for same.
- Sec. 2. That Young Explosives Corporation provide an indemnity policy with liability of at least \$2,000,000 conditioned for the payment of all damages which may be caused to a person or persons, or to property by reason of acts of the permittee, his agents, employees, etc. Such policy shall run to the Town.
- Sec. 3. That this permit is approved conditionally upon the applicant to provide lighting to the satisfaction of the Brockport Fire District. The Brockport Fire District's acceptance of the lighting and willingness to have Fire Police present during the event should be submitted to the Town of Sweden by the end of the business day (5 pm) on Thursday, September 22, 2016.
- Sec. 4. That this resolution shall take effect immediately.
