A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, September 26, 2017.

Supervisor Carges called the meeting to order at 7:00 p.m. and asked everyone present to say the Pledge to the Flag.

Supervisor Carges asked if there were any comments from the visitors.

Seymour Library Director Carl Gouveia presented the 2018 Budget and shared statistics for the past year which included program attendance, items borrowed and website visits. He showed slides of 2017 - 2018 expenditure and revenue comparisons and indicated that Sweden taxpayers would see a 0.04% increase that will allow the library to continue with reduced hours.

Supervisor Carges asked if there would be a deficit this year and Mr. Gouveia answered yes a very slight deficit. Councilperson Skoog asked what cuts were made in the budget this year. Mr. Gouveia answered library hours, staff hours and materials purchases. Library Board President LuAnne Cenci also mentioned that Mr. Gouveia agreed to a cut in hours and salary for himself. Discussion of other purchasing options for materials.

Resident Joan Hamlin mentioned a meeting in April 2016 - a resident attended a meeting to voice her concern over a vacant property in Sweden Village on Tudor Road recently purchased by a landlord. Mrs. Hamlin informed the board that the owner of the property held an open house for the neighbors to show the improvements that were made to the home – beautiful hardwood floors, finished lower level and updated bathroom. She said many of the neighbors attended and were impressed with the improvements – the owner did a great job! (Owner of said property – Norman GianCursio)

Resident Shirley Vetere commented on the "phenomenal" library. She indicated that she has lived in other communities and the Seymour Library is amazing. The Director and staff are very knowledgeable and many programs are offered at no cost. Ms. Vetere and her family spend a large amount of time there participating in programs that she describes as amazing, enjoyable, stimulating and educational.
