RESOLUTION NO. <u>18</u> Establishing Fees for Dog Licensing and Control

WHEREAS, the Town Board, as stated in Chapter 84 of the Sweden Town Code, shall establish fees by resolution for dog licensing and control.

NOW THEREFORE BE IT RESOLVED:

- Sec. 1 That the Town Board of the Town of Sweden hereby establishes the following fees for purposes of dog licensing and control:
 - A. The license fee for each dog license issued pursuant to Article II, Chapter 84 of the Sweden Town Code shall be:
 - (1) \$8.50 annually for a spayed or neutered dog which includes the \$1 New York State surcharge for the purpose of carrying out the Animal Population Control Program.
 - (2) \$16.50 annually for an unspayed or unneutered dog which includes the \$3 New York State surcharge for the purpose of carrying out the Animal Population Control Program.
 - B. The license fee for each purebred license issued pursuant to Article II, Chapter 84 of the Sweden Town Code shall be:
 - (1) \$35 if no more than 10 registered purebred dogs or purebred dogs eligible for registration over the age of four months harbored on the owner's premises at the time of the application.
 - (2) \$60 if no more than 25 registered purebred dogs or purebred dogs eligible for registration over the age of four months harbored on the owner's premises at the time of the application.
 - (3) \$110 if more than 25 registered purebred dogs or purebred dogs eligible for registration over the age of four months harbored on the owner's premises at the time of the application.
 - (4) In addition to the fee, the applicant shall pay a \$1 New York State surcharge for each spayed or neutered dog and/or a \$3 New York State surcharge for each unspayed or unneutered dog for the purpose of carrying out the Animal Population Control Program.

- C. Replacement tags shall be obtained by the owner at his or her expense at a fee of \$3 per tag.
- D. Enumeration fee. When the Town Board determines the need for a dog enumeration, a fee of \$5 will be assessed to the owner of any dog found unlicensed at the time enumeration is conducted.
- E. Seizure and impoundment fees pursuant to Article III, Chapter 84 of the Sweden Town Code shall be:
 - (1) \$20 for the first seizure of any dog owned by that person and additionally \$20 per day for each day held in the Town of Sweden kennel.
 - (2) \$30 for the second seizure, within one year of the first seizure, of any dog owned by that person and additionally \$20 per day for each day held in the Town of Sweden kennel.
 - (3) \$40 for the third and subsequent seizures, within one year of the first seizure, of any dog owned by that person and additionally \$20 per day for each day held in the Town of Sweden kennel.
- F. Adoption fee shall be \$25 for each dog.
- Sec. 2 That this resolution shall take effect January 1, 2011.
