A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, January 9, 2007.

Town Board members present were Supervisor Buddy Lester, Councilperson Rob Carges, Councilperson Patricia Connors, Councilperson Tom Ferris and Councilperson Danielle Windus-Cook. Also present were Director of Finance Leisa Strabel, Superintendent of Highways Fred Perrine, and Town Clerk Karen Sweeting.

Visitors present were residents Jim Hamlin, Bob Canham and Jim Secord and the current Seymour Library Board President Lori Lessord.

Supervisor Lester called the meeting to order at 7:30 p.m. and asked everyone present to say the Pledge to the Flag. Supervisor Lester then acknowledged the presence of the visitors and introduced Seymour Library Board President Lori Lessord. Ms. Lessord reported that the board was moving forward, emphasizing a strong sense of community. They are increasing the parameters for the director search and have received several promising applications from out-of-state. Ms. Lessord thanked Councilperson Carges for attending the anniversary celebration and thanked the Town Board for their continued support. Supervisor Lester stated that the Seymour Library was a "jewel" in our community and another example of inter-municipal cooperation.

Resident Bob Canham asked for detailed copies of the resolutions on the agenda so that the visitors attending each meeting could see in detail what the board was working on. Supervisor Lester pointed out that copies of resolutions had already been made for visitors of this meeting and included with their agenda. Mr. Canham asked if the Town had ever prepared a mission statement. He added that the Village of Brockport has a statement and directed the board to review Fulton's website which also has a mission statement. Councilperson Connors stated that she has been through the process and it is a lengthy, strategic planning process to formulate a mission statement, it is not a matter of just "whipping" up a statement. Mrs. Connors added that you must include all boards and staff to come up with a vision for the Town as a whole. Councilperson Ferris stated that New York State does NOT require it. Councilperson Carges stated that during the election the candidates state and run on their record. Supervisor Lester added that the Town Board tries to provide the most services at the best price. The needs of the Town are always changing; the Town should not be "locked in" by a statement.

### **REPORTS**

Councilperson Carges reported that he spoke with Mike Cardillo from AIRCON regarding the maintenance agreement for 2007. (Resolution tabled from December 12, 2006) There are no changes to the proposed contract. Mr. Carges also asked Mr. Cardillo for a quote to maintain the systems at the recreation center. Currently Monroe Piping maintains the systems and the contract will expire March 31, 2007. Mr. Carges provided the Board with an update regarding the acoustic paneling at the Sweden Clarkson Community Center. The Board asked that Mr. Carges meet with Recreation Director David Scott and discuss at a workshop. Mr. Carges also reported that the parking lights have been repaired at the SCCC.

Councilperson Connors reported that she attended the annual installation of new officers for the Fire Department. Mrs. Connors, along with Councilpersons Windus-Cook and Carges, dined at the Sweden Senior Center. Mrs. Connors stated that meal was very good; the hamburger was tasty and moist. Mrs. Connors also reported that she met with the mass dispensing committee, met with the Town Clerk for further updates/revisions to the Emergency Operating Plan of the Town of Sweden and attended a Department Head meeting at the Town Hall.

Councilperson Ferris also attended the installation of new officers of the Fire Department. Mr. Ferris reported that he has referred residents to the Route 531 Public Hearing being held on January 10, 2007 at the Hill School. Mr. Ferris and Supervisor Lester dined at the Senior Center and Mr. Ferris stated that the meal was fantastic and upon speaking with Nancy Duff the Senior Center Nutrition Program Site Manager, found that the responses to the ABVI meals have been positive. Mr. Ferris stated that the participants did not receive "boxed lunches" or "soggy vegetables". Mr. Ferris stated that the misinformation that residents received before ABVI began serving discouraged many. It is the job of the Nutrition Program Site Manager to make sure that ABVI maintains the quality of the meals.

Councilperson Windus-Cook reminded the Board that the Route 531 hearing would be held January 10, 2007 at 7:00 pm at the Hill School. Ms. Windus-Cook encouraged all members to attend.

Superintendent of Highways Fred Perrine reported that the sewer line installation on Redman Road is progressing. The plows and trucks are ready for the weather and salt usage is down.

Supervisor Lester reported the loss of Town employee Dan Kepler; shared calling hours and funeral arrangements with the board.
