Councilperson Ferris stated he would like to attend the Military Support Program special worship service and reception at St. John Ev. Lutheran Church (Correspondence #6) on behalf of the Town of Sweden.

Councilperson Windus-Cook had no report.

Supervisor Lester mentioned that he has been receiving positive feedback on the 2nd Annual Harvest Festival and the 5K race.

Supervisor Lester reported that he met with Sweden representatives of the Seymour Library Board. Mr. Lester would be meeting with Clarkson Supervisor Paul Kimball, Village of Brockport Mayor Mort Wexler, Village Manager Ian Coyle and Sweden Finance Director Leisa Strabel to discuss the details of the library's 14% budget increase. Mr. Lester met with a constituent who was concerned with the possible location of the Route 531 Extension. Mr. Lester contacted a representative of the NYSDOT to discuss the issue. On October 3rd, Mr. Lester participated in the Walk To School Day event and was positioned at the corner of Main and Centennial to encourage walkers. Mr. Lester received a t-shirt from Patty Jo Groenendaal, Youth Assets Coordinator, supporting "Healthy Community, Healthy Youth" partnering the Town of Sweden, the Village of Brockport, Town of Clarkson, Town of Hamlin and the school district. Mr. Lester met with Kathy Halstead of the Greater Brockport Development Corporation regarding economic development and the formation of a group to explore possibilities. Mr. Lester met with Chief Varrenti to go over procedural changes for parking tickets.

Mr. Lester attended the monthly Supervisors meeting and had an opportunity to speak with Mayor Wexler regarding the recent allegations of inter municipal relations being at an all time low. Mr. Wexler also did not agree with the allegations and agreed that the Village has several joint efforts with the Town of Sweden. Councilperson Carges added that the relations between the Village and Town have improved tremendously over the fourteen years that Mr. Carges has been on the board. Mr. Carges feels that the Town of Sweden leads the way with the concept of consolidation of services.

Superintendent of Highways Fred Perrine reminded the Board of the Fall Pickup scheduled for the week of October 22nd. Mr. Perrine announced that the Highway Department would drop off a truck for residents with large volume brush (only brush) for convenient removal at any point during the year. This is a new service offered to Town residents.

Town Attorney Jim Bell reported settlement updates to assessment lawsuits against the Town.

Trevor Speer and Scott Speer arrived at 7:45 pm. Supervisor Lester welcomed Mr. Speer and Trevor to the meeting and thanked Trevor for volunteering. (Trevor is completing an Eagle Scout project at the Town Park.) Mr. Lester stated that the Sweden Town Board appreciates volunteers and all they do for the community.

Trevor Speer reported updates on the project to the Town Board – receipt of quotes for building materials and a generous donation from Senator Maziarz. Trevor expects to begin the project by October 20th and complete the project by October 27th. The Buildings and Grounds Department would assist Trevor with the gravel pad and posts.
