Pat Coates has lived in the Brockport area her whole life and would hate to see the Senior Center close. She feels the community needs a recreation facility in the Village.

Joan Fenton is very active in the community and does not feel that we should "turn our backs" on the people that made this community what it is today. The Town needs to find a way to keep the Senior Center open.

Josephine Matela asked how each of the board members felt, was the issue discussed in public and when the board would vote on the issue.

Joan Hamlin wanted to thank the Buildings/Grounds and Highway Departments for taking such great care of the Town Park and cemeteries.

Hanny Heyen felt that a great committee was formed, the public information meeting on September 24<sup>th</sup> was attended by approximately 115 supporters and the committee had a two hour session with the Town Board.
