David F. Hugelmaier Subdivision. 8377 West Canal Road. 067.04-1-4.11, 4.12

Mr. James Colton and Mr. David Hugelmaier addressed the Board. Mr. Williams asked for clarification of the Agricultural Data Statement. Mr. Colton stated that the parcel is not located in an agricultural district. Mr. Colton further explained that this is a one-lot subdivision; joining David Hugelmaier's existing parcel with a portion of land owned by Grover Hugelmaier, his father. The dashed line represents the 1.794 acres owned by David and 1.877 acres of the approximate 46 acres owned by Grover. David Hugelmaier would like to join these two parcels to create a 3.67 acre parcel. The 1.877 acres contains the two-story frame house and barns. There is also an existing one-story frame house on the remaining lands of Grover.

Moved by Mr. Hertweck, seconded by Mr. Williams, that the David F. Hugelmaier Subdivision be accepted for review.
