## SUPERVISOR'S CORRESPONDENCE

No correspondence noted.

#### **REPORTS**

Superintendent of Highways Fred Perrine reported that brush and leaf pick up has begun. Leaf pick up will continue until it begins to snow. Crews have been working on the Flynn Road culvert replacement for Monroe County. Mr. Perrine stated they are preparing for the snow and placing snow fences. Beginning November 15<sup>th</sup>, staff will be on call twenty-four (24) hours.

Finance Director Leisa Strabel reported that she met with an insurance auditor. Several suggestions were presented.

Town Clerk Karen Sweeting announced that the Town office would be open on Saturday, November 1, 2008 from 9:00 am to 11:00 am for the sale of additional Deer Management Permits.

Councilperson Connors met with the POD committee and reported the group is nearing the end of the planning stage. The next step is to adopt the plan at the municipal level. Need to track training of personnel at each municipality. Mrs. Connors requested the board review the mileage reimbursement for the town. Employees should submit vouchers for reimbursement each month, not hold vouchers for several months. A policy needs to be adopted stating what constitutes mileage and become part of the employee handbook.

Councilperson Windus-Cook reported that she attended two luncheons at the Senior Center. Ms. Windus-Cook met with the Farmers' Museum committee to discuss the remodeling of the kitchen at the museum. They plan to bring the style of the kitchen back to the 1840s. The cabinets currently in the kitchen will be placed in the back room of the house to create functional kitchen space for catering. Gerald Hickey and John Jungbluth are volunteering with the remodeling of the kitchen. Ms. Windus-Cook also reported that the Boy Scouts would be placing a slate sidewalk from the driveway to the front door of the house. Marie Bell donated the slate pieces.

Councilperson Carges had no report.

Supervisor Lester reported that he also attended two luncheons at the Senior Center. Mr. Lester met with Lori Lessord from the Seymour Library to discuss insurance for library trustees. Mr. Lester is working with Jack Milner and Leisa Strabel on a Sweden Community Foundation presentation. Thanked Leisa Strabel for completing the "finishing touches" on the 2009 budget. Mr. Lester reported that a Notice of Claim was received from Samuel Simone regarding the rezoning decision made by the board on the property located at the corner of Lake Road and Crestview Drive in August 2008. Rezoning application for 4740 Lake Road from Residential (R1-2) to Commercial (B-1) was denied. Mr. Lester felt the Town Board acted within their right. It is the sole discretion of the board to accept or deny rezoning applications. As a courtesy, Mr. Lester asked that an invitation be directed to Mr. Simone to appear again in front of the board with the requested maps and information. The Town Board would consider the information.
