Finance Director Leisa Strabel reported two minor changes to the investment policy and will have a resolution ready for the next meeting. Mrs. Strabel is meeting with Town employees and retirees to discuss the health insurance plan for next year. The Community Block Development Grant paperwork for 2012 has been completed and she is waiting for the 2013 contract. Applications for the 2014 CBDG grants are due in February. The board discussed authorized signors for purposes of storm water management.

Councilperson Carges presented three different banner options for the Bicentennial event. Town Attorney Jim Bell is working on agreements with residents for the placement of Town signs.

Councilperson Donohue attended several community events. The Town will be responsible for a "silent display" for the Seymour Library After Hours event in 2014 and Mrs. Donohue thought that the Bicentennial committee should be involved in organizing that display.

Town Attorney Jim Bell is preparing resolutions for the subdivision and deed transfer for the Owens Road property and is drafting a letter to the Village of Brockport for acceptance of the water line. Department of Health requires the acceptance due to the increase in the size of that line. Discussion of the shared services agreement and snow removal agreement with the Brockport Fire District.

Supervisor Connors and Councilperson Carges met with representatives from the Brockport School Board to discuss the proposed exemption for the Clinton Street district.

Deputy Superintendent of Highways Brian Ingraham reported that leaf pick up was continuing, sewer lateral and concrete work at the Owens Road property are near completion and paving should begin soon. The department is getting ready for snow and ice.
