Mr. Ferris stated that the new Hamlin Supervisor also attended and looks forward to working with the Town of Hamlin.

Councilperson Windus-Cook reported that she attended a meeting to discuss the cemetery. The committee is applying for a grant to establish funds for the salvation of the foundation of the barn. She has approached the Landmark Advisory Committee for a recommendation to declare 4988 Lake Road South a Landmark of the Town.

Supervisor Lester reported that he met with the Chairperson for the Sweden Foundation to discuss several possible projects. Mr. Lester also met with the Town Engineer and the developers to discuss the proposed Lowe's development. He also attended the Supervisors' luncheon.

Building Inspector Bill Weber reported that he has been working with Deputy Town Clerk Marleen Cain on the updates to the Sweden Town Code. He stated that they should have something to present to the remaining committee members in a couple of weeks. In computing net rental income and net income from self-employment, no depreciation deduction shall be allowed for the exhaustion, wear and tear of real or personal property held for the production of income.
