<u>ECB Comments</u> – No adverse impact; the site is well landscaped with herbaceous, shrub and tree species.

<u>Fire Marshal Comments</u> – Questioned use of addition. Mr. Strabel stated at a previous meeting, it was stated the addition is for extra workspace to fit larger vehicles.

<u>Building Inspector/Stormwater Manager Comments</u> - Questioned the number of parking spaces proposed versus the number of existing shown. Mr. Glogowski confirmed there will be no change in the number of parking spaces. Mr. Glogowski corrected the application showing 22 parking spaces.

Mr. Glogowski stated the wrong address was printed on the application forms. Instead of 5328 Lake Road, it should have been 5371 Lake Road. Mr. Glogowski corrected the original forms.

Mr. Minor asked about the location of the septic system. Mr. Glogowski explained that a new septic system was installed in the back towards the west. The original one was under the parking lot. Mr. Minor confirmed that the property is serviced by public water.

Mr. Dollard questioned the note, Site Plan for Thunderbolt Automotive Re-Sales, which is the previous name for G. Wohlers Auto Sales. Also, asked what is the height of the addition? Mr. Glogowski stated the building is just being expanded out, as well as, the concrete pad.

There were no further questions to discuss.

Mr. Strabel read the questions 1 through 11, from the SEQR, Part 2, Impact Assessment; all were small or no impact. The Board agreed.

WHEREAS, the Town of Sweden Planning Board held a public hearing on November 24, 2014, and all persons wishing to be heard were heard, and

WHEREAS, the Planning Board has reviewed the Short Environmental Assessment Form, Project Information Form, comments received from the Town Engineer, Environmental Conservation Board, Building Inspector/Stormwater Manager, and Fire Marshal,

NOW, THEREFORE, BE IT RESOLVED, that the Planning Board declares itself as Lead Agency for review of this application,

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the Planning Board determines that this application is an unlisted action, which will not have a significant impact on the environment,

NOW, THEREFORE, BE IT FURTHER RESOLVED, that the final public hearing be waived, and the amended site plan be given final approval contingent upon receiving all required signatures, and the Chairman be authorized to sign the mylar.

Mr. Monno recommended that the date of acceptance for review for this application and all future applications be made part of the resolution. The Board agreed. Mr. Dollard asked that on the SEQR form, Page 2, #7, be shown as either yes or no. Mr. Glogowski stated the answer should be no and corrected it on the original form.
