RE: #1 Supervisor Lester thanked Councilperson Carges for attending the celebration and presenting the proclamation to Ms. Trek.

RE: #2 Councilperson Carges made a motion that was seconded by Councilperson Connors to accept the resignation of Matthew Sikora as Seasonal Laborer PT from the Sweden Clarkson Community Center. All voted in favor of the motion – four ayes. Councilperson Ferris had not arrived yet. Motion adopted.

DEPARTMENTAL REPORTS

November 2006 departmental reports were received and reviewed by the Town Board from the following: Receiver of Taxes, Kathleen Roberts; Finance Director, Leisa Strabel; Building Inspector, James Butler; Dog Control, Kathy Beaumont; and Town Clerk, Karen Sweeting. September 2006 and October 2006 reports were received from the Justice Court.

REPORTS

Councilperson Carges reported that the receptionist's office at the Sweden Clarkson Community Center requires another exit door. Estimates have been received and Mr. Carges would like to review them at a workshop.

Councilperson Ferris arrived at 7:40 p.m.

Councilperson Carges also reported that the gym at the SCCC echoes. There is nothing on the walls or ceiling to absorb the noise and at times it is very difficult to hear specific events going on. Mr. Carges has researched some options and suggests that estimates be received for acoustical paneling for the ceiling. The paneling is fairly simple to install with a lift and come in a variety of colors. Mr. Carges would like to discuss this further at a workshop.

Councilperson Connors reported that she met with Town Clerk Karen Sweeting to discuss several updates and changes to the Emergency Operating Plan of the Town of Sweden. Both will meet again for further review and format changes to the plan. Mrs. Connors attended the dedication ceremony of the pond at the Sweden Town Park to Town employee Dan Kepler. Mrs. Connors also attended at RPAC meeting. The Recreation Master Plan was reviewed, corrections were made and Mrs. Connors asked that the Town Board discuss and review the bylaws at a workshop and schedule a meeting with the Town of Clarkson.

Councilperson Ferris reported that he also attended the dedication of the pond to Town employee Dan Kepler.

Councilperson Windus-Cook reported that she attended the informational meeting regarding the Route 531 extension. NYSDOT is focusing on two alternatives: widening Route 31 or crossing over a portion of Route 31 around the county park continuing parallel to Shumway Road to the south and ending at Redman Road. Ms. Windus-Cook was concerned with widening Route 31. A timeline of project development steps was provided by NYSDOT. Another informational meeting for the public will be held in January 2007.

Supervisor Lester reported that he met with Charles Sanford regarding his short-term resignation. Mr. Lester met with Superintendent of Highways Fred Perrine to follow up on a drainage issue of a resident in Talamora Trail. Some further erosion control needs to be done surrounding the Super Wal-Mart when weather permits. Mr. Lester attended the VFW 2890 flag dedication ceremony at the Sweden Clarkson Community Center.

Building Inspector Jim Butler reported that he spoke with maintenance staff at the Sweden Senior Center regarding drainage issues resulting from the recent landscaping project. Mr. Butler reported several new businesses proposing to come into the Town of Sweden and the construction of two new homes.

Superintendent of Highways Fred Perrine reported that the lawn side water services have started on Shumway Road. The installation of the Redman Road sewer main will begin soon. Mr. Perrine thanked the Town Board for the pond dedication to Town employee Dan Kepler. Mr. Kepler expressed his appreciation to Mr. Perrine for the dedication.
