Mr. Schum presented a written letter to the Town Board indicating an option of rezoning with conditions. He asked the Town Board to take the opportunity to rezone the two parcels with conditions that would limit/restrict the uses in the best interest of the community. He added that numerous courts have approved it as a tool to rezone. Mr. Schum, on behalf of his client, offered several restrictions on the potential use of the properties – no restaurants, big box development, apartments, etc. Mr. Schum pointed out that the recommendation to rezone the property to commercial is stated in the Town of Sweden Comprehensive Plan and the SEQR resolution adopted by the Town Board on November 28, 2017 indicated no adverse impacts. He asked that the Comprehensive Plan be recognized when acting upon this rezoning application and felt the board should approve the application.
