At 7:15 p.m. Supervisor Milner called to order a public hearing located at the Town Hall, 18 State Street, Brockport, New York on December 28, 2010. The purpose of the public hearing was to hear all persons for or against the adoption of a local law designed to regulate ambulance services in the Town of Sweden.

Supervisor Milner asked Town Clerk Karen Sweeting to read the legal notice published in the Town newspaper. Notice was read.

Supervisor Milner explained the reason for this local law then asked if there were any comments.

Resident Bill Andrews reported that he had met with several of the Village of Brockport trustees and was told they are willing to enter into an agreement relative to the ambulance service. Mr. Andrews asked that the decision be postponed.

Resident Thomas Mangan read a letter addressed to the Town Board given to him from Village of Brockport Trustee Daniel Kuhn. Mr. Kuhn stated in his letter that contracting with Monroe Ambulance made no sense because zero dollars would remain in the community. He asked the board to postpone their decision until discussions could take place between the three municipalities to work out a solution.

Resident Pam Ketchum asked if residents requiring ambulance assistance could specify which service they wanted to respond at the time of the call. Sweden Board members answered yes and affirmed that ambulance service in the Village of Brockport would not change if the proposed contract was adopted. Monroe Ambulance would be the first responder for calls from Sweden residents unless otherwise specified at the time of the call.

No other comments were made. The public hearing was closed at 7:30 pm.
