

A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, April 12, 2005.

Town Board Members present were Councilperson Rob Carges, Councilperson Patricia Connors, Councilperson Tom Ferris, and Councilperson Windus-Cook. Supervisor Lester was not present at the beginning of the meeting. Also present were Director of Finance Leisa Strabel, Town Clerk Karen Sweeting, and Building Inspector Bill Weber. Visitors present were Jim Hamlin from 50 Park Avenue and Julie Lapinski from 4016 Sweden Walker Road.

Acting as Deputy Supervisor, Councilperson Carges called the meeting to order at 7:30 p.m. and asked everyone present to say the Pledge to the Flag led by Councilperson Connors. Councilperson Carges then acknowledged the presence of the visitors and asked if there was anyone that would like to speak. There was no one.

RE: #5 Councilperson Ferris made a motion that was seconded by Councilperson Connors to grant the request to attend the Southern Tier West Local Government Conference. All voted in favor of the motion – four ayes. Motion adopted.

RE: #6 Councilperson Ferris made a motion that was seconded by Councilperson Connors to grant the request to attend the Digital Towpath Training sessions. All voted in favor of the motion – four ayes. Motion adopted.

REPORTS

Building Inspector Bill Weber reported that one single family building permit has been issued. He also had to close a house down located at 6272 Brockport-Spencerport Road. Mr. Weber has sent a follow-up letter explaining to the owner what needs to be done. The letter was returned. He was able to track down the owner and let them know that the house must be secured and cleaned up. If there is no action, then an appearance ticket will be issued to appear in court. Neighbors have been calling with concerns regarding the property. Mr. Weber also reported that he issued an appearance ticket to Firestone for continuous violation of the sign ordinance. He asked that the board discuss the zoning changes previously submitted at the next workshop meeting.

Town Clerk Karen Sweeting reported that the Monroe County Board of Elections sent results from the US Department of Justice's audit of polling site accessibility. The Town Hall had some very minor issues that we may be required to deal with. Copies of the report will be given to the Board members for review. Mrs. Sweeting will keep the Board members informed when further information is received from the Board of Elections as to a possible "game plan".

Councilperson Windus-Cook reported that Earth Day is April 23, 2005. As part of the Stormwater Coalition requirement, the Town of Sweden, specifically Highway Superintendent Fred Perrine, is organizing a "Stormwater Stewardship" to be held on April 23. The purpose of this event is to stencil storm drains and clean up areas of the Town. Councilperson Windus-Cook also met with Don Grentzinger regarding the cemetery house being used as a Town Farmers' Museum. The consideration of a committee was discussed. Only minor changes need to be done to make the house handicap accessible. Leisa Strabel added that Fred Perrine was working on a grant to remove the existing barn. Councilperson Windus-Cook led a discussion on the concession stand at the Redman Road Park. She will continue to look into possible vendors for that purpose.

Councilperson Carges reported that he had some concerns regarding security at the Redman Road Park. Councilperson Windus-Cook agreed. He will collect proposals for security cameras and look into the possibilities that will serve the park most efficiently.

Town Attorney Jim Bell arrived at 7:50 pm.

Councilperson Ferris reported that he attended the RPAC meeting. The state of affairs of the Sweden/Clarkson Community Center was discussed and the numbers are outstanding. There were no programs "in the red" and the programs have gone beyond expectations for the year. The papers will be ready to sign creating the 501-C3 Tax Exempt Foundation to receive money to support projects in the community and the Community Center. It is a wonderful tool. They already have individuals within the community waiting to make donations.

Councilperson Connors reported that she attended the Springdale Farms Visitor Center grand opening. They built a separate building behind the parking area intended for meeting space and classrooms. Councilperson Connors also reported that the public hearing regarding the Comprehensive Plan Update 2002 was well attended by West Canal Road residents. They had many questions on the possibility of rezoning on Redman Road. It was explained that the purpose of the plan was to open up the possibilities to spread out the tax base and potentially create jobs.

Town Attorney Jim Bell reported that he had been dealing with some litigation matters for the Town.

RESOLUTION NO. 52

Ordering Public Hearing Regarding the Adoption of Local Law 3 of 2005 – Proposed Amendment to Section 175-5 Zoning Definitions – Family In the Sweden Town Code

WHEREAS, the Sweden Town Code Section 175-25 contains, among other things, a definition for “Family” to be used in that chapter of the code; and

WHEREAS, the Building Inspector has recommended a change to the definition of “Family” that will enhance enforcement of the code; and

WHEREAS, the Sweden Town Board is desirous of proceeding forward with said recommendation and proposal to change by Local Law.

NOW, THEREFORE, BE IT RESOLVED:

- Sec. 1. That the Town Board of the Town of Sweden shall hold a public hearing at the Town Hall, 18 State Street, Brockport, New York, on the 10th day of May, 2005, at 6:45 pm to hear all interested persons for or against the adoption of Local Law 3 of 2005 - proposed amendment to Section 175-5 Zoning Definitions – Family in the Sweden Town Code.
- Sec. 2. That the proposed amendment redefining the definition of Family in the Sweden Town Code is as follows:

175-5 FAMILY – ~~One (1) or more persons occupying the premises and living as a single housekeeping unit, as distinguished from a group occupying a boardinghouse, lodging house, club, fraternity or hotel.~~

A. Includes:

- 1. One (1), two (2) or three (3) persons occupying a dwelling unit; or**
- 2. Four (4) or more persons occupying a dwelling unit and living together as a traditional family or the functional equivalent of a traditional family.**

B. It shall be presumptive evidence that four (4) or more persons living in a single dwelling unit who are not related by blood, marriage or legal adoption do not constitute the functional equivalent of a traditional family.

C. In determining whether individuals are living together as the functional equivalent of a traditional family, the following criteria must be present:

- 1. The group is one, which in theory, size, appearance, structure and function resembles a traditional family unit.**
- 2. The occupants must share the entire dwelling unit and live and cook together as a single housekeeping unit. A unit in which the various occupants act as separate roomers may not be deemed to be occupied by the functional equivalent of a traditional family.**
- 3. The group shares expenses for food, rent or ownership costs, utilities and other household expenses.**
- 4. The group is permanent and stable. Evidence of such permanency and stability may include:**
 - a. The presence of minor dependent children regularly residing in the household who are enrolled in a local school.**
 - b. Members of the household having the same address for the purposes of voter registration, driver's license, motor vehicle registration and filing of taxes.**
 - c. Members of the household are employed in the area.**
 - d. The household has been living together as a unit for a year or more, whether in the current dwelling unit or other dwelling units.**
 - e. Common ownership of the furniture and appliances among the members of the household.**
 - f. The group is not transient or temporary in nature.**

5. Any other factor reasonably related to whether or not the group is the functional equivalent of a family.

Sec. 3. That the complete amendment is on file in the Town Clerk's office.

Sec. 4. That the Town Clerk is directed to cause a notice of the public hearing to be published in the Town's official newspapers as required by law.

Sec. 5. That this resolution shall take effect immediately.
