

TOWN OF SWEDEN/VILLAGE OF BROCKPORT PLANNING BOARDS PUBLIC HEARING

A Public Hearing regarding the Town of Sweden/Village of Brockport Comprehensive Plan was held by the Town of Sweden and Village of Brockport Planning Boards on **Monday, April 29, 2002**, at the Village Offices, 49 State Street, Brockport, N.Y., commencing at about 7:00 p.m.
