A special meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, May 3, 2005 following the Public Hearing. The purpose of the meeting was for adoption of the resolutions relative to the Comprehensive Plan Update 2002.

Others stayed from the public hearing but did not sign in.

Supervisor Lester called the meeting to order at 7:35 p.m. Mr. Lester acknowledged the visitors and asked if anyone had any comments. No one spoke.

# **RESOLUTIONS:**

RESOLUTION NO. 73

SEQR Determination Regarding the Amendments to the Town of Sweden Village of Brockport Comprehensive Plan Update 2002

- WHEREAS, the Comprehensive Plan Review Committee has submitted recommended revisions to the town of Sweden Village of Brockport Comprehensive Plan, that plan last having been updated and revised in 2002; and
- WHEREAS, the adoption of any proposed revisions to the town of Sweden Village of Brockport Comprehensive Plan (the Action) has heretofore been identified as a Type I Action pursuant to the State Environmental Quality Review Act (SEQRA), which classification requires the sponsors to identify other Involved Agencies, agree upon a Lead Agency and conduct a Coordinated Review for SEQRA review purposes; and
- WHEREAS, the Town Board of the Town of Sweden and the Village Board of the Village of Brockport have been identified as the Involved Agencies having the authority to approve, fund or sponsor the Action; and
- WHEREAS, the Town Board of the Town of Sweden and the Village Board of the Village of Brockport, as Involved Agencies under SEQRA, have agreed to designate the Town Board of the town of Sweden as Lead Agency for purposes of conducting a Coordinated Review under SEQRA; and
- WHEREAS, in order to aid the Lead Agency and other Involved Agencies in reviewing the potential impacts associated with the proposed action and to assist the Lead Agency in determining whether the Action may have a significant effect on the environment, the Sweden Town Board has caused to be prepared on its behalf a Full Environmental Assessment Form (EAF) Parts I and II; and
- WHEREAS, the Town Board of the Town of Sweden and the Village Board of the Village of Brockport have held a joint Public Hearing on May 3, 2005, to obtain public input

and concerns regarding the proposed amendments and revisions to the Comprehensive Plan; and

WHEREAS, the Town Board of the Town of Sweden, as Lead Agency, has duly reviewed the proposed revisions, the EAF, and other documents and comments submitted with respect to the above-referenced Action, and has duly considered the impacts which may be expected from the proposed Action and compared the same with the criteria set forth in the applicable SEQRA Regulations.

### NOW, THEREFORE, BE IT RESOLVED:

- Sec. 1. The Town Board of the Town of Sweden hereby declares that it is acting as Lead Agency for the purposes of SEQRA review concerning the adoption of amendments and revisions to the Town of Sweden Village of Brockport Comprehensive Plan and all actions related thereto.
- Sec. 2. That the Town Board does hereby accept the Environmental Record prepared by the MRB Group, Town Engineers, as being a true and accurate evaluation of the importance of the impacts associated with the adoption of the amendments to the document entitled *Town of Sweden Village of Brockport Comprehensive Plan Update 2002*.
- Sec. 3. Based upon its review and consideration of the EAF and other necessary criteria, the Town Board hereby finds that (a) the proposed Project constitutes a "Type I Action" and that (b) the object of the above-referenced Action will result in no major adverse impacts and, therefore, is not an Action which "may have a significant effect on the environment" and that since said Action will not have a "significant effect on the environment", that no "environmental impact statement" need be prepared, as such quoted terms are defined in the applicable SEQRA Regulations.
- Sec. 4. By reason of the foregoing, the Town Board hereby authorizes and directs the Town Supervisor to execute and file a Negative Declaration in the form attached hereto and to sign and date the Full Environmental Assessment Form (EAF) submitted for consideration, confirming that the Actions and all related approvals will not have a significant impact on the environment.
- Sec. 5. The Town Board hereby authorizes and directs the Town Supervisor and the Town Clerk for the Town of Sweden to forward copies of this Resolution and the Negative Declaration to all appropriate agencies.
- Sec. 6. The Town Clerk is hereby directed to maintain for public inspection a file containing a copy of this Resolution, the Negative Declaration and all submissions to date concerning the Environmental Review of this Project and all Actions related thereto.
- Sec. 7. That this resolution shall take effect immediately.
