Councilperson Connors attended the Community Awards Banquet held at the Sweden Senior Center; attended the dedication of the conference room at the Sweden Clarkson Community Center honoring former Mayor James Stull; and attended a local government workshop.

Councilperson Ferris attended a Community Foundation meeting focusing on the baseball field dedication to Ed Nietopski on May 31, 2008. Mr. Ferris encourages all to attend the event.

Councilperson Windus-Cook announced a grant awarded to the Town from Senator Maziarz in the amount of \$10,000 for restoration of the barn located at the Farmer's Museum and Lakeview Cemetery on Lake Road. Ms. Windus-Cook stressed that the Farmer's Museum was more than just a museum. The Town is utilizing the house for many things – annual Harvest Festival, quilting classes and educational events to name a few.
