Councilperson Ferris reported that he had prepared an outline for the Brockport Chamber of Commerce on the importance of moving forward with an economic development plan. Mr. Ferris met with the Director of Buildings and Grounds Jeremy Oakden to discuss work at the Senior Center. Mr. Ferris attended a Sweden Community Foundation meeting. The Foundation released money for the construction of the baseball field at the Sweden Town Park.

Councilperson Windus-Cook reported that she met with the Sweden Farmers' Museum committee and discussed the cost of building a new barn foundation and moving the barn to that foundation. Ms. Windus-Cook mentioned that the Farmers' Museum had received a large statue of a cow donated by the family of employee Ruth Kruppner whose father, William Galliford recently passed away.
