Re: Sweden Senior Center Nutrition Program

Dear Nat:

The issue of contributing to the nutrition program at the Sweden Senior Center was discussed by both the Hamlin Seniors' Executive Committee and the Hamlin Town Board. It was the consensus of both that we decline to do so.

Factors taken into account were:

- a. A review of the list of Hamlin participants indicates that many participate for the social value rather than because of need. Those who participate for the social value should not be subsidized by the town and should themselves be responsible for payment of the meals they choose to partake. Those in need have avenues available in Hamlin for assistance.
- b. The advertisement in the HAMLIN CLARKSON HERALD "invites all area senior residents to participate in daily meals." Perhaps that can be changed to limit participation to Sweden residents or otherwise clarify the situation and specify a fee to cover the added cost, which is being borne by the residents of Sweden.
- c. A similar program is being conducted by the Village of Hilton/Town of Parma which appears to be self-sufficient or at least has not become a burden to the residents of those two municipalities. Is there something they are doing different to preclude the current problems experienced by Town of Sweden?

We hope that there is some other option whereby you can control or limit meal distribution to ensure that residents of non-participating municipalities are charged a surcharge or are not otherwise encouraged by unclear advertising of a benefit for which they may not be entitled. We appreciate all that is done by the Sweden Senior Center and the residents of the Town of Sweden, who support it. However, we cannot rationalize a \$3,250 subsidy for a program that only benefits 12 residents.
