WHEREAS, the improvements proposed for the extension of municipal water service to the proposed Shumway Road/Sweden Walker Road extension to the Sweden Consolidated Water District are as follows:

- Connect to the 8" water main at the intersection of Colby Street and Sweden Walker Road (8" water main on Colby proposed to be installed in the summer of 2005).
- Install approximately 2,700 linear feet of 8" ductile iron water main and appertunenances northerly along Sweden Walker Road to the Shumway Road intersection.
- Install approximately 6,800 feet of 8" ductile iron water main and appurtenances westerly on Shumway Road from its intersection with Sweden Walker Road.
- Install approximately 2,200 feet of 8" ductile iron water main northerly off the proposed Shumway Road water main and connect to the existing 8" water main located at the southeast corner of Talamora Trail in the Highlands Subdivisions.

WHEREAS, a map, plan and report prepared by MRB Group, competent engineers duly licensed by the state of New York showing the proposed boundaries of the proposed extension and a general plan of the water system to be installed is on file in the Town Clerk's office and is available for public inspection; and

WHEREAS, the maximum amount proposed to be expended for the said improvement, as stated in the said petition, is the sum of nine hundred twenty-three thousand six hundred seventy-eight dollars (\$923,678.00), of which \$173,678 will be borne by the properties within the district on a benefits basis, and of which up to \$750,000 will be provided from the Monroe County Water Authority as part of their water main system looping project fund; and

WHEREAS the annual cost for debt service is to be financed by a benefits charge to be levied to all existing parcels within the proposed district. The benefits charge will include vacant parcels, provided they do not have an agricultural exemption. Commodity charges (for water used) will be made to all users on a quarterly scheduled and based upon their individual metered consumption multiplied by the adopted rates of the Monroe County Water Authority. Initially the water rate is estimated to be in the range of \$2.42 per 1,000 gallons along with a base charge of approximately \$11 per quarter; and

WHEREAS, at the Town's discretion individual 1 inch water services may be charged a one time connection charge estimated initially to be \$1,200 - \$1,500 per establishment, inclusive of the meter, appurtenances and inspection charges which will cover the cost of installing a service from the water main to the right of way. A separate charge arrangement for larger size services will be based upon the actual costs of upsized meter and appurtenances. In addition to this charge the individual property owner will be responsible for hiring a contractor to install the water service from the right of way to his residence or place of business, along with any reduced pressure zone devices and MCWA meter connection fees. Additional development occurring after the creation of the proposed district extension will be charged at whatever the current Water Authority connection fee is at the time; and

WHEREAS, the cost of the district extension to the typical property shall be as follows:

Annual debt service \$348
Commodity charge \$225
Total estimated annual charge per occupied parcel \$573
