In regard to number 2, Councilperson Carges requested a report by the end of September on the recent assessment update, including at least numbers illustrating the amount of work done, the changes, and a critique of the process. This time frame should enable a new assessor to become familiar with the department and complete the report.

In regard to number 3, Councilperson Ferris made a motion that was seconded by Councilperson Connors to accept the resignation of Rebecca Metzger effective July 30, 2004. All voted in favor of the motion. Motion adopted.

REPORTS

Councilperson Connors summarized what Superintendent of Highways Fred Perrine had reported earlier at a work session: that the sewer line on Fourth Section Road is waiting for Niagara Mohawk to move a power line; the reconstruction and realignment of Bethel Drive has been started and is on hold because of the weather; and the reconstruction of Shumway Road has been started.

Councilperson Carges reported that the Gallup Road water project is about 98% complete. MRB Group is completing a final punch list for the job to be completed and the final portion of the payment to Beardsley is being held until the punch list is done. The resident at

104 Gallup Road is not happy with the placement of the curb stop connection for their property. After much discussion, the settlement of the disagreement, and completion of any work required to settle it, will be included on the punch list and final payment will not be made to Beardsley until it is resolved. A note in regard to this project also is that the Monroe County Water Authority refunded \$200 to 18 residents to resolve a connection fee misrepresentation issue.

Councilperson Connors announced that the Town Board has been invited to attend the Brockport Police Department National Night Out on August 3, 2004, from 6:30 to 9:30 p.m. at the AD Oliver Middle School. The Board is also invited to attend the dedication of the downtown historic district on August 14, 2004, at St. Luke's Church.

Councilperson Windus-Cook reported that she and Councilperson Ferris met with Dog Control Officer Kathy Beaumont and discussed changes in dog control fees and Refuse/Recycling Center issues.

Supervisor Lester reported that he met with Bill Weber regarding code enforcement, M/M Westbrook regarding David Paul, Nancy Duff regarding personnel issues and the Senior Center, Charles Sanford regarding changes to the garage sale local law, a Clarkson resident on East Avenue regarding a water line extension, a resident on Fourth Section Road regarding sewer district formation and that he called Niagara Mohawk regarding the line that has to be moved for the sewer line extension on Fourth Section Road. Mr. Lester also reported that the Chamber of Commerce met and elected a new board with Elaine Bader as President.
