Mr. Bill Danno addressed the Board. He explained that the original subdivision was done in order to get a lower interest rate on a construction loan. The interest rate was lower if the house was built on five acres or less. There were never any plans to build on or sell the second lot, and in trying to simplify things, he would like to merge the two lots.

The Board reviewed the plan. Mr. Strabel noted there were a couple angle measurements missing on the NW corner of the plan. The numbers are most likely on a different map. Also, the Board asked for clarification as to the name of the lot, R-2. Mr. Danno or Mr. Glogowski should contact the County to confirm the correct name.

Moved by Mr. Strabel, seconded by Mr. Hale, that the Danno Resubdivision be accepted for review.

WHEREAS, the Town of Sweden Planning Board has received an application for resubdivision approval of the Villas at Brandon Woods – Lot 122 and Lot 123, located at 28 Wood Trace and 29 Wood Trace respectively, and

WHEREAS, the Planning Board has reviewed the comments of the Town Engineer,

NOW, THEREFORE, BE IT RESOLVED, that the final hearing be waived and the Villas at Brandon Woods, Lot 122 and Lot 123 Resubdivisions be granted final approval contingent upon receiving the signature of the Town Engineer, and the Chairman be authorized to sign the mylar.

Mr. Monno asked if there is a square footage limit for these lots. Mr. Schultz stated the maximum square footage was approved with the original plans requiring a separation setback of 20 ft. between townhomes. He added that there is extra depth available so if the footprint needs to be moved back there is room. Mr. Monno asked what the typical square footage of a townhome is. Mr. Schultz stated this one is 1,657 square feet.
