Mr. Patrick Laber distributed updated copies of the plan and stated the following:

- The DOT approved the entrance where it's shown on the plans and requested the east side be flared out quite a bit for truck traffic.
- Sewer was extended along the frontage of the property to GBR's property.
- Sidewalk service was added to the plans as well as landscaping across the entire frontage.
- The DOT will be asking for cross access between Spurr's parking lot and GBR's property on either side; cross access will be deeded.
- The plans have been signed by the Town Engineer, Highway Superintendent, Water Authority, Pure Waters, Health Department and the Fire Marshal is ready to sign tonight.

Mr. Laber added that the pond issues were settled. A copy of the letter signed by Mr. Hogan was given to the Board granting construction of the pond improvements be completed, and acknowledging that either an easement over the pond or a dedication of the pond be granted to the Town.

Chairman McAllister requested that the following note be added as #10 to the plans:

As per the NYSDOT, access to parcels 084.01-01-05 and 084.01-01-06.31 will be via the curb cut being constructed to Rt. 31 as part of this application.
