The Stone Soup Auction on September 17th was a success. A meeting regarding a Colby Street water project with the MCWA was postponed. A resident is continuing to work on obtaining grant money for a water project on Redman Road.

Finance Director Strabel reported that insurance rates should remain flat for next year. Attorney Bell reported that the Natapow case has been postponed until January 2005.

Supervisor Lester stated that he had ridden with Building Inspector Weber to look at sign violations in the town. Mr. Weber has a first draft of proposed changes to the code completed. Mr. Lester requested that a copy go to the Town Attorney.

Superintendent of Highways Perrine reported that Shumway Road should be done at the end of next week. Driveways and oil and stoning are what remain to be done. The department is working on the Fourth Section Road sewer project again. They have encountered four to five feet of rock near the surface. They will work on Ellis Drive and landscaping along Bader's Way and possibly in November, a retention pond west of the parking lot at the Community Center.
