A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, January 13, 2009.

Town Board members present were Supervisor Buddy Lester, Councilperson Rob Carges, Councilperson Patricia Connors, Councilperson Tom Ferris and Councilperson Danielle Windus-Cook. Also present were Director of Finance Leisa Strabel, Superintendent of Highways Fred Perrine and Town Clerk Karen Sweeting.

Visitors present were residents Vesta Teeter, Cora Schrader and Village Trustee Maria "Connie" Castaneda.

Supervisor Lester called the meeting to order at 7:30 p.m. and asked everyone present to say the Pledge to the Flag led by Councilperson Windus-Cook.

Supervisor Lester acknowledged the visitors and asked if anyone would like to speak. Resident Cora Schrader complimented Dave Scott, Recreation Director for the presentation given at the Senior Center. Mr. Scott welcomes all to the center and states that all are equal at the center regardless of their place of residence.

Resident Vesta Teeter stated that the Sweden Senior Association formed a committee, of which Norman Wright, Vesta Teeter and Cora Schrader are members of, to research the possibility of purchasing a generator and ice machine for the Senior Center. Ms. Teeter reported that they have looked into several options for a generator. Discussion with Town Board on the size of the generator requested and what the generator would sustain during a power outage. The Town Board suggested that the committee continue researching the costs and factors involved with installation and to keep options open.

Ms. Teeter stated that monies are available for the purchase of an ice machine from the Jim Rich Memorial Fund. The committee is asking the Town Board for approval to install and maintain the ice machine. Maintenance and costs to run the machine are minimal. Town Board approved the request for the installation and maintenance of an ice machine purchased using monies from the memorial fund.

Cora Schrader was happy with the creative programs offered for seniors and commented that the prices are reasonable.

Supervisor Lester addressed Village Trustee Castaneda regarding the 2009 Fire Contract. Mr. Lester stated the Board desires to hold their share of the escrow amount so that residents of the Town of Sweden have a right to vote on capital expenditures of the fire department. As it is now, Sweden residents and Clarkson residents pay 80% into escrow, which is held by the Village, and only Village residents are able to vote on capital expenditures. Mr. Lester believes that Sweden residents should have a vote on expenditures using their tax dollars.

Councilperson Connors made a motion that was seconded by Councilperson Windus-Cook to accept the minutes of the Regular Town Board Meeting held on December 30, 2008. All voted in favor of the motion – four ayes. Supervisor Lester abstained due to his absence on that date. Motion adopted.

Councilperson Connors made a motion that was seconded by Councilperson Windus-Cook to accept the minutes of the Organizational Meeting held on January 2, 2009. All voted in favor of the motion – four ayes. Councilperson Ferris abstained due to arriving late on that date. Motion adopted.

Based upon the review by the Town Board of the EAF and other necessary criteria, the Board hereby finds that the object of the above-referenced action (a) will result in no major impacts and, therefore, is not one which "may have a significant effect on the environment," (b) will not have a "significant effect on the environment," and (c) no "environmental impact statement" need be prepared, as such quoted terms are used in SEQRA. The proposed Project does not constitute a "Type I Action" as such quoted term is defined in the regulations of the Department of Environmental Conservation of the State of New York (6NYCRR Part 617, as amended). Reasons supporting this determination are set forth on the notice of negative declaration of the Board attached hereto and hereby made a part of this resolution for the purposes of SEQRA. This determination constitutes a negative declaration for purposes of SEQRA.

Sec. 2. A copy of this resolution, together with the notice of negative declaration, shall be placed on file in the office of the Clerk of the Town where the same shall be available for public inspection during business hours and such notice of negative declaration shall be filed in such offices, posted in such places and published in such newspapers as shall be necessary to conform to the requirements of SEQRA.
