A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, July 27, 2021.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Randall Hoke, Councilperson Rhonda Humby, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Superintendent of Highways Brian Ingraham, Town Attorney James Bell, and Town Clerk Karen Sweeting.

Visitors present were Chris Hamlin and Karen LoBracco.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our fighting men and women around the world, members of law enforcement, and first responders.

PRIVILEGE OF THE FLOOR:

No comments.

CORRESPONDENCE:

1. Taysie Pennington – note complimenting the Town on the Sweden Town Park facilities.

REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Town Attorney Jim Bell requested Executive Session to discuss some issues. Finance Director Leisa Strabel reported that the Town received the first payment of ARPA (American Rescue Plan Act) funds.

Superintendent of Highways Brian Ingraham reported completion of the County Line Road bond project, Swamp Road paving project, and are close to finishing Skidmore Drive bond project. They are assisting the Towns of Ogden and Parma and the County with road projects. Mr. Ingraham reported drainage work on Persistance Path, Mull Lane, and Isla Way.

Councilperson Hoke reported that IT will be reducing the number of computers they are supporting in the Court because Office of Court Administration currently supports those systems. The Court can no longer suspend licenses for failing to pay fines. They will now have to place civil judgments on individuals that owe fines. Mr. Hoke has been working with the Building Department conducting a long-term study on feasibility and workload. Mr. Hoke shared information on the voice-over IP option. The system is a significant upgrade and will save the Town money. The Sweden Traffic Safety Committee met again. Superintendent of Highways Brian Ingraham attended the meeting. A community survey will go out to residents, and they have the results of the speed trailers.

Councilperson Humby reported that the Sweden Farmers Museum is now open. She met with Christine Hunt and took a tour of the house and barn. The committee is reconvening to discuss ideas for revitalizing the barn and house back to that period – stage it and make it more appealing. They are still dealing with bats in the barn. Ms. Humby appreciates all the hard work that goes into keeping it clean. She is hoping they can get the Harvest Festival going again next year. The mowing at the cemetery continues and the grounds look great. Dog Control has been busy. They had an adoption event to benefit the shelter. The rabies clinic will be held on Saturday, August 14, 2021 at the SCCC. Appointments are filling up. Ms. Humby has met with

a representative from the County Health Department and Jill Wisnowski, Recreation Director to discuss the details and how to get the information out to the public. Ms. Humby noted that on July 15th she attended the Village's adaptive kayak launch event.

Councilperson Sullivan reported that the Splash Park, playgrounds, and Skate Park have been busy. The Lodge rentals continue to be strong. The gazebo dedication was well attended. Buildings and Grounds have been busy. They are waiting for the ground to dry to get a lift in for the scoreboard. Several downed trees have been cleared off the trails. Roof repairs were done at the Town Hall and 133 State Street. They are looking into some field concerns on Nietopski Field – obtaining quotes. The batting cage carpet needs to be replaced; they are considering rubber mats. Mr. Sullivan suggested purchasing pitching and catchers mound tarps. The Brockport Blizzard tournament was held – due to the rain, many fields were closed.

Councilperson Hayles shared the Seymour Library Board reports. They are operating within their budget. The library will be presenting their budget to the Town of Sweden, Village of Brockport, and Town of Clarkson on August 24, 2021 at 7:30 p.m. (Sweden invited the other municipalities to attend one presentation.) The proposed Operating Agreement and Lease is still under review. The 2020 audit is in progress.

Councilperson Hayles reported that all programs are now open at the Sweden Clarkson Community Center following current COVID guidelines. The grant was received for the Senior Room Addition. The July 3rd celebration was a success – large number of attendees. They are planning the Halloween event and the brochure will be out soon.

Supervisor Johnson commented on the low numbers for spring and summer sports. Discussion of how to increase registrations.

Supervisor Johnson reported that he participated in the Memorial Day Ceremony at the Oliver Middle School. The monthly meetings at the Highway Department continue. Held several status conferences on the water line installation – went through a checklist of items. The monthly Supervisors' lunches continue. They discussed the increase in violence and the new marijuana legislation. Mr. Johnson participated in the Challenger Baseball event – many volunteers, tremendous event.

Supervisor Johnson met with the Library Director – impressed with how things are going. The Council of Governments met and discussed proposed shared services – software/IT sharing, vacant property portal, equipment sharing.

Supervisor Johnson shared the passing of June Killigrew who worked for the Town from 1979-2003.

Supervisor Johnson provided project updates. The Park path to the canal is nearly complete. A skate park grant meeting is scheduled for August 17th – they will discuss the project and RFP. The proposed Senior Addition is moving forward. Mr. Johnson shared information pertaining to the new marijuana legislation. Discussion. Mr. Johnson updated the board on the cost of rock blasting for the water district. The Town Engineer will be coming to an upcoming meeting to discuss the one-way option for the Gary Drive Extension.
