<u>Supervisor Johnson</u>: Good evening, we are going to call this evening's regular meeting of the Sweden Town Board to order. I am going to ask everyone to rise wherever you are as we recite the Pledge.

All Board Members: I pledge allegiance to the Flag of the United States of America and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.

<u>Supervisor Johnson</u>: Thank you everyone. If you remain standing for a moment, as we observe a moment of silence. Tonight, let's remember both our fighting men and women around the world protecting our freedoms, our first responders, as we always do, and especially during this time when they're acting with selflessness and bravery. And, then finally let's remember the families and those dealing with this disease firsthand. (Silence) Thank you.

<u>Supervisor Johnson</u>: Alright, because of the situation I am going to waive reports and the privilege of the floor this evening, and there is no correspondence to note.

So, for the public as well as for the rest of the Board, good evening and welcome to the regularly scheduled Sweden Town Board meeting of March 24, 2020. This meeting is being conducted remotely in compliance with the Governor's Executive Order No. 202.1, filed on March 7, 2020 suspending Article 7 of the Public Officers Law. The suspension allows municipal boards to hold meetings by conference call provided that the public has the ability to view or listen to such proceedings and that the meetings are recorded and later transcribed.

I am here at the Sweden Town Hall. Attending the meeting by telephone are Deputy Supervisor Bob Muesebeck. Bob if you could note that you are on the line, please.

Deputy Supervisor Muesebeck: Yes, I am.

Supervisor Johnson: Councilperson Patricia Hayles.

Councilperson Hayles: Hello.

Supervisor Johnson: Councilperson Randall Hoke.

Councilperson Hoke: Randy Hoke, present.

Supervisor Johnson: Councilperson Rhonda Humby.

Councilperson Humby: Present

Supervisor Johnson: Town Attorney James Bell

Attorney Bell: Present

Supervisor Johnson: Town Clerk Karen Sweeting

Clerk Sweeting: Present

Supervisor Johnson: Director of Finance Leisa Strabel.

Director of Finance Strabel: Here

<u>Supervisor Johnson</u>: Is there anyone else on the line from the Town? (Silence) Ok, thank you.

We are meeting this way because we believe it is important to practice social distancing as our federal, county and state officials have advised. We want every one of our Town of Sweden employees to remain healthy; we want our residents to remain healthy. In short, we are committed to doing our part to flatten the curve of the COVID-19 virus.

This meeting is being streamed live to the Town of Sweden Supervisor Facebook page. It is also being audio-recorded and will be transcribed and made available on our website as soon as practical.

The majority of our business tonight is minor: several sets of minutes will be approved and our monthly abstract of bills paid. Before those minor items are approved, we are taking one important action and that is I am declaring a State of Emergency for the Town of Sweden this evening.

Why are we taking this action? The simple answer is, in the words of the Boy Scout motto, to be prepared. The State of Emergency allows me, as Supervisor, to take action without constantly reconvening the Town Board when decisions need to be made quickly. It allows me, as the Supervisor, the authority to expend funds and assign personnel, supplies, equipment and facilities in response to an emergency without bureaucracy or red tape slowing the process.

It also allows the Town of Sweden to be eligible for federal or state assistance that may be forthcoming in regards to the emergency. As of tonight, there are no personnel, supplies, equipment or facilities being assigned; the declaration merely gives me the authority to do so if the need arises within the next thirty days. At the end of the thirty days, the State of Emergency expires unless I feel it is necessary to extend it.

Now I want to tell you what this declaration is not. It is not a cry for immediate help or assistance. I believe our Town's current needs are being cared for adequately. Nor is it a symbol of fear or panic. Your Town Board has been actively and tirelessly preparing for the outbreak of this virus locally for weeks, starting with our Board voicing concerns over residents' concerns over the quarantine at SUNY Brockport just a few weeks ago, until today when those early concerns seem so small in comparison to the reality of this virus spreading across the nation. As Supervisor, I cannot express my appreciation and awe at watching the way that this Town Board and all of the Town's employees have reacted to this national crisis. Rest assured that we will continue to plan for and serve the needs of our residents with clear eyes and minds, unclouded by fear or panic. We will base our decisions on the facts, and not on speculation or emotion.

I am now going to read the Town of Sweden's State of Emergency Declaration and at the end ask for my fellow board members' support. This request for the support of other Board members is not required by law, but it is an important step to show the residents of our Town that the Town Board is united in solidarity on this measure.

Town of Sweden State of Emergency:

Both the State of New York and the County of Monroe have declared a State of Emergency related to the COVID-19 crisis. In following, I specifically find as the Sweden Town Supervisor that the COVID-19 crisis imperils the public health and safety of both individuals and businesses in the Town of Sweden. Taking into consideration various Executive Orders and related emergency guidelines issued by the County of Monroe, the State of New York and the United States of America, and after consultation with federal, state and local governmental departments, I find it to be in the best interests of the Town of Sweden for me to hereby issue a State of Emergency in the Town of Sweden allowing me the discretion to, amongst other things, use any and all facilities, equipment, supplies, personnel and various other Town of Sweden resources as required to cope with this emergency. Consequently, and pursuant to Executive Law Section 24, I hereby declare a State of Emergency effective March 24, 2020 at 9:00 p.m. in the Town of Sweden, County of Monroe, State of New York. This State of Emergency shall remain in effect for a period not to exceed thirty (30) days commencing on the aforesaid date and time unless and until either rescinded or extended by me for an additional period not to exceed thirty (30) days. Any residents in need of special or emergency assistance are advised to contact 911. All residents are advised to monitor the website for the Town of Sweden as well as local media reports for updates. And, I will sign that today.

Deputy Supervisor Muesebeck, do you support me in this declaration?

Deputy Supervisor Muesebeck: Yes, I shall.

Supervisor Johnson: Councilperson Hayles, do you support me in this declaration?

Councilperson Hayles: Yes, I do.

<u>Supervisor Johnson</u>: That's a "yes" from Councilperson Hayles. Councilperson Hoke, do you support me in this declaration?

Councilperson Hoke: Yes, Sir, I do.

Supervisor Johnson: Councilperson Humby, do you support me in this declaration?

Councilperson Humby: Yes, Sir, I do.

<u>Supervisor Johnson</u>: And that's a yes from Councilperson Humby. Thank you all of you for your support in this.

A few more notes from the Town of Sweden before we go into our regular agenda. The Sweden Town Hall has been closed for one week as of today. Many of our employees are working from home and are allowed to access their offices for a brief time during the day, as is necessary. Our highway and building and grounds departments are working on a rotating, limited schedule to limit any exposure of any of those employees. Our community center is completely shuttered, although many of our dedicated employees there are working remotely as best they can.

Should you need anything from any department of the Town, the phone numbers and/or email addresses for each department in the Town are posted on the Town of Sweden Supervisor Facebook page as well as on our Town website – <a href="https://www.townofsweden.org">www.townofsweden.org</a>. Furthermore, should you not know where to turn for any need related to the Town, please call my cell phone anytime, the number is 585-615-5243. The entire staff of the Town is committed to meeting our residents' needs as best we can during this time.

The Town Board will continue to make decisions about closures, cancellations and work schedules based on the directives given to us by federal, state and local health authorities. We will continue to keep you, our residents, as up-to-date as possible via the website and Facebook.

There has been an outpouring of requests by our residents of "what can I do to help?". Because of that, I want to let you know about a few immediate needs. First, the Red Cross is experiencing a precipitous drop in blood donations, and during this time of increasing needs in our medical system, this issue must be addressed quickly. There are two local blood drives coming up, both will be held at the Brockport Fire Department Exempt's Club at 248 West Avenue in Brockport. The first is this Thursday, March 26 from 11 a.m. to 5 p.m. and then the second will be held on April 9 from 1 p.m. to 6 p.m. Rest assured that the Red Cross has taken all of the necessary precautions to ensure the health and safety of donors. Please visit the Red Cross website or my Facebook page to learn more.

The second need has to do with the elderly in our community, and was noted on a call I had with County officials today. There are significant needs for volunteers to provide both transportation as well as to deliver meals to elderly people within our community. If you are willing and able to provide any such help, please call the Monroe County Coronavirus hotline at 753-5555. Again, that is the Monroe County Coronavirus hotline at 753-5555.

If there is anything else we, as a Town, can do to address problems or concerns in our community, or raise awareness of a problem or need, please do not hesitate to contact us.

Isn't it wonderful that during a time of social distancing, we are all coming together like never before. Please continue to abide by the recommendations of federal, state and local officials so that together we can defeat this virus and get back to normal life as soon as possible. This will end, and may we all take courage in that.

Anyone else on the board, uh, any other business or comments? (Silence) Alright.

Town Attorney Bell: I have, uh, excuse me, Jim Bell. Kevin when you sign the State of Emergency, you need to sign at least four of them in originals.

Supervisor Johnson: Ok, I can do that.

Town Attorney Bell: Under Executive Law 24, they need to be dispersed in different ways, that I can speak to you and the Town Clerk and the Chief Financial Officer tomorrow about, but. Sign at least four of them if you would please.

Supervisor Johnson: Ok, I certainly will.

Supervisor Johnson: Alright, can I have a motion to go into Executive Session please?

Councilperson Hayles: This is Patty Hayles, so moved.

<u>Supervisor Johnson</u>: Alright, thank you Patty with the motion, and could I have a second?

<u>Supervisor Johnson</u>: Bob, thank you for the second. Alright, we will take a voice vote, all in favor say aye.

Councilperson Hayles: Ave

Supervisor Johnson: Aye

Councilperson Hoke: Aye

Councilperson Muesebeck: Aye

Councilperson Humby: Aye

<u>Supervisor Johnson</u>: Ok, that was unanimous. Any opposed? (Silence) Very good. We will go into Executive Session and for the information of the public we will not be coming back to our regular meeting to transact any business. Thank you very much. Good night. (Recording ended - Executive Session began at 6:16 p.m.)

At 6:43 p.m., Councilperson Hayles made a motion that was seconded by Councilperson Humby to leave executive session. All voted in favor of the motion. Motion adopted.

As there was no further business to come before the Board, Councilperson Hoke moved to adjourn the March 24, 2020 meeting of the Sweden Town Board at 6:44 p.m. Councilperson Muesebeck seconded the motion. All voted in favor of the motion. Motion adopted.
