Deputy Supervisor Hayles explained that the request is to extend the district by one household at no cost to the Town, decreasing the annual debt service for properties currently within the district.

Councilperson Humby asked how much lower the cost would be for properties within the district. Finance Director Leisa Strabel explained that there are approximately 150 units and adding one additional unit would lower the annual debt service by just a few dollars.

PUBLIC HEARING:

At 6:45 p.m. Deputy Supervisor Hayles called to order the public hearing. The purpose of the public hearing was to hear all public comments on the Town of Sweden's Community Development Block Grant (CDB) CARES Act application, "Senior Room Addition to Address Social Distancing, Ventilation, and Sanitation" for the 2021 program year.

Visitors present were Recreation Director Jill Wisnowski, Barb Grady, and Robert and Betty Coopenberg.

Deputy Supervisor Hayles waived the reading of the legal notice.

Mrs. Hayles explained that the addition of a senior room at the Sweden Clarkson Community Center will address social distancing, ventilation, and sanitation for seniors at the center. The current senior room has no windows and seniors must pass through public areas to get to it. The Town of Sweden is seeking \$500,000 for public facilities with the principal purpose of benefitting low to moderate income persons.

Mrs. Hayles stated that the current senior room is used for a variety of recreational programs and instructional classes, it is where the senior association plans trips and events and is a gathering place for seniors to socialize. Prior to COVID, the room was often filled to capacity, which is no longer possible. In order to continue delivering services to seniors, participants will require more space to facilitate social distancing, better ventilation to improve air quality, a hand washing station to help prevent the spread of viruses, and an entryway that does not pass through a large group of other citizens. Single user handicap accessible restrooms will also help protect seniors from the spread of viruses.

Mrs. Hayles said the Town proposes to construct a new Senior Room in order to prevent and respond to COVID. It will be double the size of the current room allowing the seniors to maintain social distancing, encouraging more seniors to return to the center. The new room will have windows and a ventilation system that will better clean the air. There will be a hand washing station in the room to facilitate frequent hand washing. The new room will be located directly off the front lobby eliminating the need for seniors to walk through other public areas, reducing close contact. The plan also includes two single occupancy handicap accessible restrooms. Mrs. Hayles shared an architectural draft of the proposed addition.

Mrs. Hayles detailed the project budget totaling \$1,100,000. The sources of funds would come from the Town's building reserve, operating budget, and the CARES Act grant. It is all predicated on getting the grant. Mrs. Hayles shared several US Census statistics relating to our population and door counts for the Sweden Clarkson Community Center. She feels the numbers justify the expenditure. The Clarkson Supervisor has expressed her support. Written public comments will be accepted through May 14, 2021.

Opened for comments.

Barb Grady, resident of the Town of Clarkson and member of the Sweden Senior Singers group, commented that windows and proper ventilation are important to singers. She said this proposed project was a positive thing for seniors and encourages the board to proceed. She also felt that the hand washing stations and restrooms were a positive addition to the proposed room. Mrs. Grady asked if the board felt they could maintain the space after construction. Mrs. Hayles explained that the board has considered the operating costs of the addition. The board would not propose an addition if they did not feel they could support it in the future.

Betty Coopenberg, resident of the Town of Clarendon, shared that the seniors used to hold many events, such as dinners, dances, etc. and asked if these events could continue and whether any of the funds could be used for kitchen updates. Mrs. Hayles agreed that the kitchen required updates, but it could not be part of this grant application. Finance Director Leisa Strabel confirmed that kitchen updates were not an allowable request. Discussion of the concerns with the current kitchen.

Mrs. Coopenberg said she and many other seniors are in favor of the addition and feels it will encourage more seniors to attend and participate. Mrs. Grady indicated that many of the singers were also in favor of the addition.

Recreation Director Jill Wisnowski spoke in favor of the proposed addition. No other comments. Public hearing closed at 7:13 p.m.

ADJOURNMENT:

As there was no further business to come before the Board, Councilperson Humby moved to adjourn the May 11, 2021 meeting of the Sweden Town Board at 7:14 p.m. Councilperson Sullivan seconded the motion. All voted in favor of the motion – four ayes. Motion adopted.
