<u>Supervisor Johnson</u>: Ok, good evening everyone. We're going to call this evening's regular meeting of the Sweden Town Board to order. The first thing, I'd just like to remind everybody, if you could, please mute your phone unless you are ready to speak on something. I think it will help with clarity on the call. So, I'd ask you to please stand and we'll recite the Pledge together.

<u>All Board Members</u>: I pledge allegiance to the Flag of the United States of America and to the Republic for which it stands, one Nation under God, indivisible, with liberty and justice for all.

<u>Supervisor Johnson</u>: Ok, thank you and if you remain standing as we observe a moment of silence, remembering our fighting men and women around the world, all of our first responders, and as well as those who have been affected in the difficulty of this pandemic. (Silence) Thank you.

Alright, the first item on the agenda this evening is correspondence. I have nothing to report to the Board on that. And as a reminder we have reports on May 26<sup>th</sup>, which is our next regular meeting, two weeks from tonight, so please be prepared with those. No one signed up for privilege of the floor so there's no one to speak at this time so we'll move right into the consent agenda.

  - RESOLUTION NO. <u>65</u> Accept Decommissioning Bond <u>Helios Sweden Solar Farm</u>
- WHEREAS, Helios Energy New York 3 LLC & Helios Energy New York 10 LLC have submitted a Decommissioning Plan to the Sweden Planning Board and Sweden Town Engineer for two solar panel arrays located on lands identified as Tax Map No. 098.04-1-2.1 at Lake and Swamp Roads; and
- WHEREAS, in a memo dated May 7, 2020, MRB Group approved the Decommissioning Plan as meeting the requirements of the Sweden Town Code; and
- WHEREAS, in the same memo dated May 7, 2020, MRB Group deemed as adequate the sum of \$313,674.60 as the financial security required to cover the costs of removing said facilities from the site should the solar energy owner fail to do so; and
- WEREAS, the applicant has submitted a draft form of the Decommissioning Bond.

## NOW, THEREFORE BE IT RESOLVED:

- Sec. 1. That the Town Board of the Town of Sweden accepts the Decommissioning Plan for the Helios Energy Site on Lake and Swamp Roads, Tax Map No. 098.04-1-2.1 as recommended by the May 7, 2020 MRB Group memo.

## **NON-CONSENT AGENDA:**

<u>Supervisor Johnson</u>: We have nothing on the Non-Consent Agenda this evening.

### ADDITIONAL BUSINESS AND ANNOUNCEMENTS:

<u>Supervisor Johnson</u>: So, at this point, we'll move into other business. Is there anything that anyone on the Town Board would like to share with the Board or talk to the Board about before we do move into an Executive Session.

Town Attorney Bell: This is Jim. I would just put out there that our State of Emergency is going to expire in the next three or four days. Am I correct in assuming that we are extending that?

<u>Supervisor Johnson:</u> Jim, do you have any advice for the Board on that in terms of what other municipalities or the state is doing, anything you might recommend?

Town Attorney Bell: Well, I don't really know what's going to happen as far as funding is concerned with the next stimulus bill if there is one, but my opinion and advice would be to extend it. If something should happen that you want to rescind it, you could always rescind it before the next thirty-day period is up after you extend it. But it's going to expire here, I believe, on the, I'm doing the math as I'm talking to you, on the 14<sup>th</sup> of May. So, we're going to want to extend it by then if you are going to extend it.

<u>Supervisor Johnson:</u> Well Jim, I believe the State did extend theirs for another thirty days, if I'm not mistaken.

Town Attorney Bell: I think that's correct and I think some of the other municipalities, I haven't talked to a lot of municipal attorneys in the last week, but the ones I have talked to are continuing to extend them when they're getting close to the expiration date.

<u>Supervisor Johnson:</u> Ok, does the Board have any thoughts or objections?

<u>Councilperson Hayles:</u> Jim, are you saying that we should extend because of the possibility of funding for, if there's funds available because we are in a State of Emergency, we'd want to protect that possibility?

Town Attorney Bell: Yes, that is, that is what I am saying. I am not, necessarily, guaranteeing that it's going to trickle like that, but, yes, that is what I'm saying. I'm sure there would come a point where we would have to make a showing of law to be eligible for funds, but that's exactly what is being debated in Congress right now is this entire subject. So, it would seem to me as though we'd be in a better position to assert ourselves or our position if we still have a State of Emergency in effect.

<u>Councilperson Hayles:</u> Then I think we should extend the State of Emergency to protect that possible interest in those funds.

Town Attorney Bell: If that's what the Board is desirous of doing, and the Supervisor, I will prepare the documents.

<u>Supervisor Johnson:</u> I think, Jim, that simply can be done with my signature. I don't think that it requires any Board action but we have asked for consent on the past two.

Town Attorney Bell: You're correct it requires your signature only, that's correct.

Supervisor Johnson: Ok, and the date for that was?

Town Attorney Bell: Well, the last one, the last extension was April 14<sup>th</sup>, so, and that was for thirty days, so do the math, it's going to run out on the 14<sup>th</sup> of April which is the day after tomorrow. Uh, May.

<u>Supervisor Johnson:</u> Excellent. Well if you would get something to us, I will certainly sign it and extend it. Again, I don't, we did some research on this at the beginning as I recall and

we're not aware of any funding opportunities that are predicated on us having a State of Emergency. Nonetheless, we don't know what any final bill coming out of the Congress might be, so I think to preserve, to preserve that possibility I think we should, we should extend. Although, I think that, as we begin, as everybody begins the reopening process, albeit slowly, at some point, even just for symbolic reasons we should probably rescind it. But I think, let's keep it open until we see what the Feds do and go forward.

Town Attorney Bell: I will prepare it.

<u>Supervisor Johnson:</u> Ok, very good. Alright, anything else, other business from the rest of the Board? (Silence)

## **EXECUTIVE SESSION:**

Supervisor Johnson: Ok, what I'm going to ask for is a motion to go into Executive Session. The purpose of this Executive Session is, has to do with matters which concern the safety of the public and I would like to invite into that Executive Session the Town Attorney, the Highway Superintendent, Brian Ingraham, and Jill Wisnowski the Recreation Director and then finally the Finance and HR Director of the Town, Leisa Strabel. So, could I have a motion for Executive Session, please?

Councilperson Muesebeck: So moved, Bob.

Councilperson Hayles: And a second, Patty.

<u>Supervisor Johnson</u>: Ok, any discussion on the motion? (Silence) Ok, then if I could, can I have a, we'll just do a voice vote on this. All in favor say aye. Aye.

Councilperson Hoke: Aye

Councilperson Muesebeck: Aye

Councilperson Humby: Aye

Councilperson Hayles: Aye

<u>Supervisor Johnson</u>: Any opposed say nay. (Silence) Alright, we will move into the Executive Session at this time. There will be no official business transacted in the Executive Session. We will be moving straight to adjournment after that. Thank you everyone. (Recording ended - Executive Session began at 6:10 p.m.)

At 7:42 p.m., Councilperson Hayles made a motion that was seconded by Councilperson Humby to leave executive session. All voted in favor of the motion. Motion adopted.
