- Sec. 2. That surplus monies from the town outside general fund balance may be deposited into this Capital Reserve Fund as authorized by resolution of the Town Board of the Town of Sweden.
- Sec. 3. That the Supervisor is directed to deposit and secure the moneys of this Capital Reserve Fund in the manner provided by section 10 of the General Municipal Law.
- Sec. 4. That the Supervisor is authorized to invest, from time to time, the monies of this fund pursuant to Section 11 of the General Municipal Law.
- Sec. 5. That any interest earned or capital gains realized on the money so deposited or invested shall accrue to and become part of this Capital Reserve Fund.
- Sec. 6. That no expenditure shall be made from this fund, except upon authorization of this Board, pursuant to Section 6-C of the General Municipal Law, and subject to permissive referendum if required by subdivision 4 of Section 6-C of the General Municipal Law.
- <u>Sec. 7.</u> That this resolution shall take effect immediately.

Authorize Supervisor to Sign Server Replacement Proposal CETech

WHEREAS, the Town of Sweden's IT Consultant, CETech, has proposed replacing the Town's physical server at a cost of twelve thousand eight hundred sixty eight and ninety hundredths dollars (\$12,868.90); and
