RE: #1 Supervisor Milner stated that the rehabilitation project would start later than anticipated. Start date of September 2009 with expected finish date of late 2010.

REPORTS

Superintendent of Highways Fred Perrine reported the county DOT job on Flynn Road is complete; clearing and grading along Brockport Spencerport Road south side of Wal-Mart Supercenter is complete and ready for seeding; and catch basin repair work is complete. The intake line for irrigation has been installed at the Town Park and the pond has been cleaned out. They are waiting for watermain materials to come in for the park. Several burials have been done at Lakeview Cemetery. Mr. Perrine announced that the Annual Stormwater Report would be submitted this week and available on the web site. The report is a joint report mostly compiled by the Stormwater Coalition with input from area towns.

Councilperson Windus-Cook reported that she attended the Veterans celebration and community recognition held by the Brockport area Veterans Club. Ms. Windus-Cook announced that the Sparkleberry Twig is hosting a movie night at the Sweden Farmers' Museum on June 12, 2009 at 8 pm. Shrek 3 will be played. Rain location at the Sweden Clarkson Community Center gymnasium. All proceeds to benefit Lakeside Memorial Hospital.

Councilperson Ferris had no report.

Councilperson Connors will hold the last Ballroom dance class this Thursday. Mrs. Connors volunteers to teach this class every year.

Councilperson Carges reported the recent car break in at SCCC. The incident was caught on video and the Monroe County Sheriff is investigating.

Town Attorney Jim Bell reported that he was in Sweden Town Court prosecuting parking violations at the Town Park. The board discussed methods of collections and violators failing to appear (Criminal Summons to be issued.). The board hopes that by issuing parking tickets to violators, it will result in a safer environment for patrons of the park. Mr. Bell stated he has given approval for the agreement with McLean Development for waterline construction. (Resolution No. 48 of May 16, 2009.)

Director of Buildings and Grounds Jeremy Oakden reported regular maintenance is being done to Nietopski Field. The board discussed areas of concern. Mr. Oakden also reported that the generator was at the Senior Center waiting for the electrician to install.

Finance Director Leisa Strabel reported that she and Supervisor Milner met with Town Auditor Christopher Trento to review the 2008 audit report. The Town's financial position is strong and continued to grow stronger in 2008. The Town Board worked diligently throughout the year to control costs. The results are reflected in the audit report which shows that Town spending decreased in 2008 as compared to 2007. This despite the fact that many factors, ie increased health insurance costs and fuel prices were beyond the Town's control.

Supervisor Milner reported that he attended the Veterans celebration and community recognition held by the Brockport area Veterans Club, a public access cable meeting and the Memorial Day celebration at the Brockport Middle School. Mr. Milner stated that he was meeting with the Brockport area Rotary Club to present the Sweden Community Foundation and his position as Town Supervisor.
