A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, October 26, 2021.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Randall Hoke, Councilperson Rhonda Humby, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Highway Superintendent Brian Ingraham, Town Attorney James Bell, and Town Clerk Karen Sweeting.

Visitors present were Chris Hamlin, Kevin M. Johnson, and Karen LoBracco.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our fighting men and women around the world, our first responders, and those affected by COVID.

### PRIVILEGE OF THE FLOOR:

Resident Karen LoBracco said she took advantage of early voting yesterday at the Sweden Clarkson Community Center and shared comments that she heard from the inspectors.

#### CORRESPONDENCE:

No correspondence noted.

# REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Councilperson Hayles reported that the SCCC pumpkin walk is tonight, and Thursday night is the usual Halloween festivities. Mrs. Hayles commented on the third quarter financial report and feels they are quickly approaching a pre-COVID level. Jill and her staff are controlling their budget very well.

Councilperson Hayles reported that the Seymour Library has come a long way since the preliminary budget presentation on August 24<sup>th</sup>. They are committed to restoring the hours of operation to 53. Mrs. Hayles discussed the grants and funding levels. She asked if the annual four-board meeting should be scheduled. Supervisor Johnson suggested that meeting be scheduled after the first of the year.

Councilperson Sullivan reported that repairs on the Nietopski scoreboard have been completed, new paint and lettering. The wind-weighted weather tarps for home plate and the pitcher's mound have been ordered. The batting cage flooring will be replaced. They are advertising for a field groomer. Supervisor Johnson explained that the position is a third position that has been left unfilled. They would like to hire an individual with field grooming experience to perform annual maintenance. The Lodge rentals continue.

Councilperson Humby complimented Jill Wisnowski on her job performance. Mrs. Humby reported that Dog Control has been busy. The cemetery map project is complete. Thank you to Ruth Kruppner at the Highway Department for helping with the project. The Farmers Museum Committee met and will form a Harvest Festival committee to plan the 2022 event. The Farmers Museum is now closed for the season. The committee will be organizing the items in the house.

Councilperson Hoke reported nothing notable going on with the court. Mr. Hoke informed the board of a property maintenance situation on Brockport Spencerport Road. The

building department has flagged the house for safety reasons, and they have been in contact with the owner. Mr. Hoke reported that the new phone system installation is moving forward.

Supervisor Johnson said that he would like to form a committee to draft short-term rental legislation. Mr. Johnson mentioned the new law pertaining to open meetings. The meeting agenda and packet will be posted 24 hours prior to the meeting. He asked the board members to review resolutions by Monday at noon.

Supervisor Johnson attended the Town/Gown Committee meeting. He was asked to provide Town updates at those meetings. Mr. Johnson met with David Strabel regarding the plan for the senior addition. Mr. Johnson participated in the annual Walk-to-School event and welcomed the Monroe County Town Clerks to the Town of Sweden for their association meeting. Mr. Johnson met with the Highway Department and with members of the Sweden Senior Association. He attended the Sweden Community Foundation meeting. The topic of discussion was the skate park. Fundraising letters will go out over the next couple of months.

Supervisor Johnson announced that the Village of Brockport is holding a public hearing on the cannabis legislation this coming Monday at the Oliver Middle School.

Supervisor Johnson provided updates on the current and future water projects. The Town received the completion letter from the Department of Health – water is flowing. Based on the report from MRB Group, the Town is unable to install lateral stubs on all the roads, so the east/west connections were prioritized. They determined that Beadle Road west intersection, LaDue Road intersection, and Swamp Road intersection are the best options at this time.

### **PUBLIC HEARING**

At 6:26 p.m. Supervisor Johnson called to order the public hearing. The purpose of the public hearing was to hear all persons interested in the budget, in favor of or against the Preliminary Budget for 2022, or any item therein to include the compensation to be paid to all elected Town Officials, pursuant to the requirements of Section 108 of the Town Law.

Supervisor Johnson waived the reading of the legal notice.

Supervisor Johnson presented the 2022 Budget. He detailed Town services provided and the categories within the budget. He detailed the summary showing the breakdown for the Village (\$2.436385 tax rate) and the Town outside the Village (\$4.038265 tax rate). Mr. Johnson shared the tax rate history showing a stable tax rate over time. He explained tax levy trends, the taxable assessed valuation summary, and detailed the exemptions. Mr. Johnson shared the list of special districts, elected official salaries, bond indebtedness and the tax cap calculations. This year the cap is 2.0%. The Town is \$16,504 below the tax cap.
