A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, September 22, 2020.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Robert Muesebeck, Councilperson Patricia Hayles, Councilperson Randall Hoke, and Councilperson Rhonda Humby. Also present were Finance Director Leisa Strabel, Superintendent of Highways Brian Ingraham, Town Attorney Jim Bell, and Town Clerk Karen Sweeting.

Visitors present were John and Sandra Cassin, Christine Mayer, Don Grentzinger, Chris Hamlin, Joan Hamlin, Wayne Zyra, Megan Baker, Brandy Schill, Shannon Parmele, Kevin Parmele, James Baker and James Cenci.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our first responders, those affected by COVID, and our fighting men and women around the world.

# PRIVILEGE OF THE FLOOR:

Resident Megan Baker read a letter sent by Attorney Daniel F. Brennan to the Town Board via email on September 22, 2020 opposing the proposed Gary Drive Extension. (on file in the Town Clerk's office)

Resident John Cassin addressed the board opposing the proposed Gary Drive Extension project. He is concerned with an increase in traffic and is looking forward to seeing the traffic study.

Resident Sandra Cassin addressed the board opposing the proposed Gary Drive Extension project.

Resident Shannon Parmele addressed the board opposing the proposed Gary Drive Extension project. She is concerned about the safety of the children on Gary Drive.

Resident Christine Mayer addressed the board opposing the proposed Gary Drive Extension project. She shared a video of traffic within Sweden Village along Gary Drive taken on September 11, 2020 due to an accident on Route 31.

Resident Kevin Parmele addressed the board opposing the proposed Gary Drive Extension project. He travels east every day and still opposes the project and is also concerned with the safety of children.

Resident James Baker addressed the board opposing the proposed Gary Drive Extension project. He referenced issues with the 531-extension project and the presence of the sheriff in Sweden Village.

# REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported that county projects on Reed Road and Gordon Road are complete. They assisted the Town of Wheatland and the Village of Brockport with road projects. The Highway Department parking lot reconstruction project is coming along. The Town Park roadway project continues, and Mr. Ingraham hopes to have that open soon for Dog Park traffic. The first phase of repair on Swamp Road is complete. The concrete pad for the gazebo at the Town Park is complete and the gazebo was set in place on Friday. Finance Director Leisa Strabel reported that the Tentative Budget is now on file, all Board members have a copy. There were a few minor changes resulting from discussions at the last workshop. The Board is scheduled to adopt the Preliminary Budget at the October 13<sup>th</sup> meeting. Mrs. Strabel is still waiting for the retirement system numbers and open enrollment for health insurance is coming up.

Councilperson Hayles reported that the SCCC is under the control of the Department of Health in how things reopen. Things are going well – classes are being scheduled with much lower numbers, the fitness center is open with only four people allowed at a time. The Fall brochure is out. Recreation Director Jill Wisnowski talks with the Health Department almost daily to determine what programs they may be able to begin – things are changing constantly. Basketball may begin by November 1<sup>st</sup>. Mrs. Hayles commented that Jill and her staff are doing a great job. The center is only open for scheduled programs.

Councilperson Hayles shared the summary reports provided by Clarkson representative Pat Galinski. Sally Snow is now the interim director – Mike Boedicker resigned to accept another position. They are working on the budget and have requested an extension. Mrs. Hayles explained that there are several new members and they have been asking many questions. They are looking to balance the budget without cutting the hours of operation for the library. The MOU is progressing. The Town of Clarkson has drafted their final edits. The library, Village of Brockport and Town of Sweden have approved the MOU in its current form. The Town of Sweden is looking for a third trustee. Mrs. Hayles connects with Sweden's representatives monthly.

Supervisor Johnson shared Clarkson's anticipated budget reduction for the library. Discussion.

Councilperson Muesebeck reported that new COVID filters have been installed at the SCCC. The front AC unit at the Town Hall has been repaired. The playgrounds have been used frequently even with cooler weather conditions and the lodge rentals are still coming in. The first hole on the disc golf course is now open. We have received many compliments on the disc golf course. The last cleaning of the Dog Park pond is underway. Baseball and flag football are in progress. The seasonal mowers will be done October 8<sup>th</sup> until next year. The gazebo was delivered and set on Friday.

Councilperson Humby reported the changes in Dog Control. The rabies clinic is scheduled for Saturday, September  $26^{th}$  – drive-thru and appointment only. The Sweden Farmers Museum is still closed. Mrs. Humby complimented the work being done at the SCCC by Ed Stieve.

Councilperson Hoke reported that IT has been quiet. The court has a part-time vacancy for court clerk. They are accepting applications until Friday.

Supervisor Johnson noted two items of correspondence. The letter from Attorney Daniel Brennan that resident Megan Baker read during "privilege of the floor" and a letter requesting endorsement from the Supervisor for PILOT program approval for Heritage Square. Mr. Johnson added that the Town also has vacancies for two support boards, the Board of Assessment Review and the Seymour Library Board. Mr. Johnson and other members of the board attended the 911 ceremony at the Capen Hose Company. He met with Councilperson Humby and the new dog control officers to discuss details relative to the position and kenneling contract with the Town of Hamlin.

Supervisor Johnson reported that the sidewalk is complete on Holley Street. The next section will be Isla Way. The Town is working out the details for the Persistence Path section.

Mr. Johnson said the highway department is on track for completing the capital road projects. The Town is waiting for approvals from several agencies for the water district project, hoping to bid the project out in November. The Stonebriar Phase II project will be coming back in front of the Board with a revised traffic pattern plan. Bentley Brothers have acquired the abandoned house near their business, they may be submitting a rezoning application. Supervisor Johnson met with Councilperson Muesebeck and Sam Simone to discuss a proposal for the property at the intersection of Route 19 and Crestview Drive.
