

A special meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, March 19, 2024.

Town Board Members present were Supervisor Patricia Hayles, Councilperson Scott Maar, Councilperson Tyler Sharpe, Councilperson Adam Staskiewicz, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Town Attorney Jim Bell, Superintendent of Highways Brian Ingraham, and Town Clerk Karen Sweeting.

Visitors present were John and Sandra Cassin and Tony Gianni.

Supervisor Hayles called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence.

NON-CONSENT AGENDA:

- RESOLUTION NO. 62 Authorizing Temporary No Parking Prohibitions

WHEREAS, pursuant to Sweden Town Code §170, the Sweden Town Board is empowered to, by Resolution, establish temporary "no parking" prohibitions for specific streets, or parts thereof, for events or other occurrences where the Sweden Town Board finds such to be reasonable and necessary to protect public safety, and

WHEREAS, the Sweden Town Board has been advised by the Monroe County Sheriff's Department, and other governmental agencies, that traffic during the "Eclipse Event" on April 8, 2024 is predicted to be heavier than at any other known date with potentially hundreds of thousands of visitors in the general vicinity, and

WHEREAS, the safety of Sweden residents and visitors is in part dependent upon the ability of emergency vehicles to traverse Sweden streets and roads, and

WHEREAS, the Sweden Town Board, in order to facilitate the movement of emergency vehicles through Sweden on April 8, 2024, is desirous of prohibiting parking on specific Sweden streets and roads for the 24-hour period 12:01 a.m. April 8, 2024 to 11:59 p.m. April 8, 2024, and

WHEREAS, a Public Hearing was held at the Sweden Town Hall, 18 State Street, Brockport, New York, on March 12, 2024 at 6:15 p.m. and at that time the Sweden Town Board heard public comments from those wishing to be heard.

NOW THEREFORE BE IT RESOLVED:

Sec. 1. No vehicle shall be parked at any time upon any of the streets or parts thereof described in "Schedule – Parking Prohibited at All Times" on file in the Sweden Town Clerk's Office pursuant to Sweden Town Code §170-7 (Exhibit A

attached hereto).

Sec. 2. In addition to the foregoing, no vehicle shall be parked at any time on the side of any street, road, drive, driveway, way, circle, trail, lane or terrace (described in Exhibit B attached hereto) containing odd numbered addresses for the twenty four (24) hour period 12:01 a.m. April 8, 2024 to 11:59 p.m. April 8, 2024.

Sec. 3 This Resolution shall take effect immediately.
