A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, April 26, 2022.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Rhonda Humby, and Councilperson Gary Sullivan. Councilperson Hoke was Also present were Finance Director Leisa Strabel, Superintendent of Highways Brian Ingraham, Town Attorney Jim Bell, and Deputy Town Clerk Kathleen Roberts.

Visitors present were Chris Hamlin, Karen LoBracco, Pat & Bill Leonard, Dottie Scott, Kathy & Terry Swanger, Anna & Jamie Hintz, Nelson Kibler, and Jeanne & Vic Derefinko.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our first responders and all our military service men and women and especially for those on the Mercy Flight that crashed today.

PRIVILEGE OF THE FLOOR:

Resident Pat Leonard addressed the Board with reasons she felt public water is needed on Covell Road. Supervisor Johnson explained why they have not been able to move forward at this time and offered to meet with her some time to go more into depth about financial projections and other details.

CORRESPONDENCE:

Notification of receiving Community Development Block Grant for sidewalks on Crestview Drive in Sweden Village.

REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported that work on Gary Drive is continuing nicely with the concrete gutters and sidewalks being completed. Spring clean-up is this week with a large amount of brush needing to be picked up after all the wind we have been experiencing. Next week they plan to be installing conduit for the lights and light poles along Gary Drive and Route 31. That will be followed by the final layer of stone and paving being done. Mr. Ingraham also reported that they are wrapping up on snow and ice, removing snow fencing and repairing any lawn damage. Interments have started along with clean-up and mowing at the Cemetery.

Deputy Supervisor Hayles attended the library annual meeting and has worked on drafting a municipal survey with questions to be asked with the goal of increasing the useage of the library. The Towns of Sweden and Clarkson and the Village of Brockport will be given the opportunity for their input as to the questions and format. Mrs. Hayles also reported that the Seymour Library Nifty Fifties After Hours Event is on May 7, 2022. The Farmers Museum Committee continues their work on the Fall Harvest Festival, to be held on September 17, 2022, with many exciting events planned. On May 21, 2022, Museum Night will be held at all the local museums including the Farmers Museum, Seymour Library & Local History Room, and the Emily L. Knapp Museum.

Councilperson Sullivan reported that the batting cage flooring is done and the benches in Nietopski Field have been replaced with new. The broken glass top of the stove in the Lodge has

been replaced. The gap in the new sign at the Recreation Center has been fixed and also some work in the gym. Mr. Sullivan reached out to the Superintendent of Highways, Brian Ingraham, about filling potholes at the entrance to the Town Park and it should be done by the first week in May. Minor repairs to the Seymour Library roof have been made. Mr. Sullivan also reported that Roger Evans will be available at the Day of Caring to be held at the Senior Center to help with mulch and trimming. The Splash Pad is scheduled to open Memorial Day weekend. Mr. Sullivan added that the Sweden Community Foundation plans to have a booth at the Arts Festival to raise additional funds for the Skate Park by a brick donation.

Councilperson Humby reported that the Community Easter Event held on April 9, 2022 was successful with 260 attendees and \$321 being raised for the Brockport Food Shelf. Baseball begins next week, soccer begins in June, and plans for Summer Camp are being made. Mrs. Humby also reported that she had conversation with Jill Wisnowski, Recreation Director, about ideas for getting the word out and promoting the Fitness Center. There will be a Community Garage Sale in the gym at the Recreation Center on May 7, 2022 and also a bake sale and basket drawing by the Sweden Senior Association. Mrs. Humby reported that the senior addition at the Recreation Center is coming along nicely. Regarding Dog Control, Mrs. Humby reported that it was a busy month with 27 Sweden residents being served. She also attended a meeting with the dog control officers, Town Attorney Jim Bell, and the Town Supervisor to go over policies and procedures and possible code changes.

Supervisor Johnson reported that they will have another meeting regarding the Skate Park design on Thursday, April 28, 2022 with the representative from Spohn Ranch. He also reported that the committee for Short Term Rentals will be meeting again on May 10, 2022. In regard to the Water District, there is restoration work to be done and also months of paperwork. Mr. Johnson mentioned that due to County restraints, the Crestview Drive sidewalks will not be constructed until next year. He also reported that he has had a couple informal meetings about rezoning parcels on Sweden Walker Road for commercial use. Mr. Johnson shared good news that he has had some interest in funding or sponsoring a portion of the Skate Park. He also announced that the flag placement for Memorial Day will be May 21, 2022, meeting at 9 am at Lakeview Cemetery, to distribute maps and flags to be placed at all five of the cemeteries.
