A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Tuesday, November 29, 2022.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Randall Hoke, Councilperson Rhonda Humby, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Highway Superintendent Brian Ingraham, Town Attorney James Bell, and Town Clerk Karen Sweeting.

Visitors present were SUNY Brockport students Amanda Blakely and Margaret McSweeney.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our fighting men and women around the world and our first responders.

PRIVILEGE OF THE FLOOR: No comments.

CORRESPONDENCE:

No correspondence noted.

### REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Superintendent of Highways Brian Ingraham reported that Fall leaf pickup continues until December 9<sup>th</sup>. Snow and ice equipment preparation in progress and finishing the grading work at the new skate park.

Finance Director Leisa Strabel reported representatives from Albany will be coming to tour and complete the monitoring interview for the new senior addition and the last bills will be paid this evening. The Town audit will begin in three weeks.

Councilperson Hoke shared the Building Department report. Fire Marshal, Lyle Stirk, was called to a structure fire on Reed Road. They issued 19 building permits, bringing the total permits to 188 as of November 25<sup>th</sup>, up from last year; 35 certificates were issued (Certificate of Compliance, Certificate of Occupancy and Fire Inspection Certificate); and 2 violations were issued. Mr. Stirk is catching up on annual fire inspections and attended a Hazard Mitigation meeting. No report for IT.

Councilperson Humby reported that due to discussion at a work session, effective December 1, 2022, all new dog licenses issued will be required to sign an affidavit swearing that the dog has not been deemed dangerous by any court. Hamlin Dog Shelter is looking for donations. A new recreation brochure is out. They have a roller-skating event planned, a youth/adult dance program, and the swim program is back. A Valentine's Day event and movie event have been scheduled in the new senior addition. An Eagle Scout is proposing to construct benches near the GaGa Pit.

Councilperson Sullivan reported that Buildings and Grounds continue to winterize the Town Park. He provided updates on the construction of the new skate park and the brick paver patio. He will be meeting with some individuals to discuss improvements to the Disc Golf Course at the Town Park. Councilperson Hayles reported that interviews will begin for the Library Director position at Seymour Library. Updates to the budget were provided pertaining to a surplus. Mrs. Hayles provided the library survey to the Seymour Library Board. She met with the President and Vice President of the Library Board to continue relations between the Town and library. The Farmers Museum will meet in January to start planning the 2023 Harvest Festival. The committee feels the museum is underutilized and will be working with Cornell Cooperative to bring a variety of programming to the museum. Mrs. Hayles attended the Veterans' Event held in the new senior addition.

Supervisor Johnson asked Superintendent of Highways Brian Ingraham for the timeline of removal for the old skate park. Mr. Ingraham intends to remove the fence and skate equipment during the winter season. Finance Director Leisa Strabel is working with a vendor to split the equipment into saleable pieces. Supervisor Johnson anticipates a May/June grand opening for the new skate park.

Supervisor Johnson reminded the Board that there is special legislation that allows the Town to sell advertising space on the fences at the Town Park. They are drafting some pricing to offer to local businesses. They are working on obtaining draft designs for signs at the entrances to Sweden Village – Sherry Lane, Crestview Drive, and Sweden Lane. The water study update is almost complete. MRB Group will be invited to present those changes to the Board and then a public meeting will be announced. The Crestview sidewalk project will begin in the Spring. The benches have been placed in the open lot on Sherry Lane and Highview Circle. Mr. Johnson also attended the Veteran's Day event.

Supervisor Johnson mentioned the increase in property crime in the Town. At a recent Supervisors Association meeting, he suggested writing a joint letter to New York State asking for their thoughts on the increase. A letter was drafted and sent to the state, copying the Sheriff. Mr. Johnson attended a meeting discussing the increase in crime all over Monroe County. Legislation was drafted and will be sent to Albany for consideration.

Councilperson Humby made a motion that was seconded by Councilperson Hayles to approve **all** Consent Agenda items as listed below.

Discussion: Supervisor Johnson noted for Resolution No. 138 – Authorize Supervisor to Sign Proposal Architectural Services Town Hall Renovations that this is the first step in moving forward with renovations at the Sweden Town Hall. They will gather information from the Town Hall staff.

Councilperson Hayles – referring to Resolution No. 139 – Authorize Purchase of 2023 F-550XL Dump Truck to Replace F-450 Dump Truck – stated she is in favor of the purchase but was concerned with the increase in "carrying" costs of a larger vehicle. The Superintendent of Highways, Brian Ingraham, felt the costs would be minimal.
