A regular meeting of the Town Board of the Town of Sweden was held at the Town Hall, 18 State Street, Brockport, New York, on Thursday, December 29, 2022.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Randall Hoke, Councilperson Rhonda Humby, and Councilperson Gary Sullivan. Councilperson Patricia Hayles was absent. Also present were Finance Director Leisa Strabel, Superintendent of Highways Brian Ingraham, Town Attorney Jim Bell, Building/Code Enforcement Officer and Fire Marshal Lyle Stirk, Town Historian Christine Hunt, and Town Clerk Karen Sweeting.

No visitors were present.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our first responders and our fighting men and women around the world.

CORRESPONDENCE:

Resignation from Mary Ann Thorpe, Chairperson Zoning Board of Appeals

REPORTS OF BOARD AND DEPARTMENTS:

Superintendent of Highways Brian Ingraham reported on the recent storm. They were busy with salt applications and removing downed trees due to high winds. Mr. Ingraham thanked his crew for their hard work during the storm.

Town Historian Christine Hunt provided the Town Board with a report for 2022. Ms. Hunt is working to establish an office for the Town Historian at the Sweden Farmers Museum and creating a filing system for historic records. She thanked the board for the opportunity to attend the NYS Preservation Conference. Ms. Hunt would like to re-establish visitation hours for the house and barn; establish a library of books, ledgers, journals, and related materials for public viewing; and organize a Beech Ridge Cemetery Tour for the Spring of 2023. Ms. Hunt would like to collect stories of houses within the Town. She asked the Town Board for some technical assistance, computer access at the Farmers Museum, and several bookshelves.

Councilperson Sullivan reported that indoor work will begin at the recreation center – painting and installation of wainscoting in the hallway.

Councilperson Humby reported that dog control has been quiet. The Christmas event at the Sweden Clarkson Community Center was a success – approximately 200 people in attendance. Ms. Humby is looking forward to the family rolling skating event in February.

Councilperson Hoke shared the Building Department report pointing out comparative statistics for 2021-2022. Fire inspections are now required every three years due to Chapter 64 changes recently adopted by the board based on NYS recommendations. There were twenty complaints filed this year and twenty-six violations issued.

Supervisor Johnson attended an Environmental Conservation Board meeting and a Sweden Community Foundation meeting. Mr. Johnson also attended a Council of Governments meeting to discuss and pass the Shared Services Agreement. Due to the threat of the storm, Mr. Johnson connected with National Grid. During the storm Mr. Johnson contacted the Brockport School District to discuss and organize a warming center. He has reviewed our Emergency Operating Plan and would like to coordinate a meeting with other area officials to streamline an emergency process.
