**Town of Sweden American with Disabilities Act Grievance Procedure** This grievance procedure is established to meet the requirements of the ADA. It may be used by anyone who wishes to file a complaint alleging discrimination on the basis of disability in the provision of services, activities, programs, or benefits by the Town of Sweden.

The complaint should be in writing and contain information about the alleged discrimination such as name, address, phone number, email address of complainant and location, date, and description of the problem. Alternative means of filing complaints, such as personal interviews or a tape recording of the complaint will be made available for persons with disabilities upon request.

The complaint should be submitted as soon as possible, preferably within 60 calendar days of the alleged violation to:

Within 15 calendar days after receipt of the complaint, (the Sweden Town Supervisor) will meet with the complainant to discuss the complaint and the possible resolutions. Within 15 calendar days of the meeting, the Sweden Town Supervisor will respond in writing, and where appropriate, in format that is accessible to the complainant, such as large print, Braille, or audio tape. The response will explain the position of the Town of Sweden and offer options for substantive resolution of the complaint.

If the response by the Sweden Town Supervisor does not satisfactorily resolve the issue, the complainant may appeal the decision within 15 calendar days after receipt of the response to the Sweden Town Council.

Within 15 calendar days after receipt of the appeal, the Sweden Town Supervisor or designee will meet with the complainant to discuss the complaint and possible resolutions. Within 15 calendar days after the meeting, the Sweden Town Supervisor or designee will respond in writing, and, where appropriate, in a format that is accessible to the complainant, with a final resolution of the complaint.

Sec. 2. That this resolution shall take effect immediately.

#### PUBLIC HEARING

At 6:30 p.m. Supervisor Johnson called the public hearing to order. The purpose of the public hearing was to hear all persons interested in the re-zoning of approximately 3.492 acres of land on Colby Street approximately 4,539 feet west of Sweden Walker Road from B-2 Airport Commercial to I-2 Light Industrial.

Supervisor Johnson waived the reading of the legal notice.

Supervisor Johnson acknowledged the applicant, Henry Conradt, and Anthony Tintera from Meagher Engineering.

Anthony Tintera provided additional materials, including aerial images and concept layout, to the Board. Mr. Tintera described the project site and surrounding area, detailing the current neighborhood uses in proximity to the project. The applicant is proposing to construct storage units. Mr. Tintera addressed concerns received from other Sweden boards, outside agencies, and the Town Engineer dealing with setback requirements, spot zoning, and use variances instead of rezoning.

Henry Conradt, applicant, detailed the concept plan, explaining that the units will look like airport hangars, approximately 12 feet in height. He owns storage units in a neighboring Town and feels there is a demand for this type of business.

Resident Don Pophal asked for a copy of the map and the specific location of the project. Discussion of location. Mr. Pophal asked if there were any FAA restrictions. Mr. Conradt stated they have height restrictions and pointed out the no-build zone. Councilperson Sullivan asked how many units they propose to construct. Mr. Conradt provided the length of each building and estimated around 170. Discussion.

No other comments. Public hearing closed at 6:50 p.m.

#### ADJOURNMENT:

As there was no further business to come before the Board, Councilperson Humby moved to adjourn the January 10, 2023 meeting of the Sweden Town Board at 6:51 p.m. Councilperson Hayles seconded the motion. All voted in favor of the motion – four ayes. Motion adopted.
