A regular meeting of the Town Board of the Town of Sweden was held at the Sweden Town Park Lodge, 4761 Redman Road, Brockport, New York, on Tuesday, March 28, 2023.

Town Board Members present were Supervisor Kevin G. Johnson, Councilperson Patricia Hayles, Councilperson Randall Hoke, Councilperson Rhonda Humby, and Councilperson Gary Sullivan. Also present were Finance Director Leisa Strabel, Town Attorney Jim Bell, and Town Clerk Karen Sweeting.

Visitors present were James Cenci and Bernie and Karen LoBracco.

Supervisor Johnson called the meeting to order at 6:00 p.m. and asked everyone present to say the Pledge to the Flag and remain standing for a moment of silence to remember our first responders and our fighting men and women around the world.

REPORTS OF DEPARTMENTS AND BOARD MEMBERS:

Councilperson Hoke will provide the board with a copy of the Building Department report. Mr. Hoke received some interest from a potential vendor for IT services and would like to reconsider looking at some numbers this year.

Councilperson Humby reported that Dog Control is getting busier – seven service calls this month, no major issues. Recreation has been busy planning the upcoming Easter event and several new programs. Mrs. Humby met with Finance Director Leisa Strabel, Recreation Director Jill Wisnowski, Supervisor Johnson, and Highway Superintendent Brian Ingraham to discuss several updates to the Sweden Clarkson Community Center both inside the building and outside. They discussed the kitchen area and updates to the outdoor basketball courts to include a pickleball court.

Councilperson Sullivan reported that Buildings and Grounds have been busy painting and completing minor repairs inside the Sweden Clarkson Community Center. The Town Park had some minor damage due to the recent winds. The Highway Department has been working on the new section of road to the skate park lot and removing fencing. Mr. Sullivan stated they are looking into hiring someone to work during the Summer on the weekends and after hours for activities at the park.

Councilperson Hayles reported that things are moving along at the Farmers Museum. The Gardening classes through Cornell Cooperative are filling up fast. Harvest Festival planning continues.

Supervisor Johnson reported the surface of the old Quonset hut at the Town Park is in fairly good shape and would like to use that existing space. The Town Hall renovations are moving forward. The boiler replacement bid award is on the agenda. Mr. Johnson met with the Town Court staff to discuss the upcoming renovations – targeting June/July for a start date. Working on design details for the Town signs and Sweden Village signs. Mr. Johnson

mentioned several NYS DOT projects – East Avenue/Sweden Walker Road intersection and Route 31, along with Main Street bridge closings. He mentioned there are a few interested parties in the 133 State Street property.

Visitors present were James Cenci, Martha Clasquin, Carol Gravetter, Marianne Virgilio, Charlotte and Norman Wright, Lynne Gardner, Linda Negus, Andrew Gardener, Courtney Miller, Mike Schaffer, and Carolyn and Harold Mundy. Others were present but did not sign in.

Seymour Library Board President Bernie LoBracco welcomed everyone and thanked all for attending. Mr. LoBracco noted that 2022 was a challenging year for staffing. He introduced Library Director Patrick Pittman.

Seymour Library Director Patrick Pittman explained that he has modified the annual report to fit his style. He began by explaining the library's mission statement and why they do an annual report. It is a useful data set and tool. The Director described the core values – intellectual freedom, education, literacy, lifelong learning, and access. The library answered 8,124 reference questions last year.

Director Pittman felt 2022 was a good year. They are progressing in many categories. There was a significant increase in meeting room use, computer logons, and normalization of interlibrary loans. He spoke on circulation trends, door counts, and programs noting several survey results and the implementation of those ideas. They are still determining what the best hours are for the library and what programs will increase door counts.

Director Pittman shared staffing concerns from 2022 and briefly detailed the budget and several concerns. They are moving forward with a long-term plan, strengthening communications with stakeholders and the community, and working to create an attractive and welcoming environment.

Director Pittman answered questions from the board members present.

Councilperson Hayles, liaison to the Library Board, announced that a summary of the survey results is available online. They continue to use the information gained from the survey moving forward.

Discussion of the library parking lot.

As there was no further business to come before the Board, Councilperson Hayles moved to adjourn the March 28, 2023 meeting of the Sweden Town Board at 7:54 p.m. Councilperson Hoke seconded the motion. All voted in favor of the motion. Motion adopted.
